

Introduction

The Human Relations Commission (HRC) was established in 2007 by the Albany City Council to strengthen connections within Albany's diverse community by being committed to the philosophy of inclusion, equal opportunity, fair treatment for all residents of Albany and promoting harmonious relations among the citizens of Albany.

It was created to recommend programs, activities, ordinances, expenditures, and other appropriate governmental activities which will serve the goal of maintaining respectful interactions within our community. The HRC recommendations are submitted to the City Council and City Manager.

In formulating its recommendations, the HRC strives for actions that lead to positive and respectful relations committing to diversity, equity, and inclusion in the community. The duties of the Commission do not include the investigation or sanctioning of individual acts of unlawful or discriminatory behavior, but instead focus on recommending community activities that may be expected to promote positive change.

A history of commission membership and attendance is attached to this report, along with a calendar of 2018 HRC meetings and events that HRC members attended.





JANUARY

01/23/19 — NEW COMMISSIONERS APPOINTED

New commission members Jessi Brenneman and Jo Rae Perkins were appointed to the Human Relations Commission.

FEBRUARY

02/26/19 — GAPS ASSISTANT SUPERINTENDENT LISA HARLAN

Lisa Harlan joined commissioners and discussed the challenges and successes faced in the Greater Albany Public School District. One of the school district's goals is to see that the school system demonstrates that each student is receiving what they need. The needs of one student could be very different from those of another student.

Another goal is for students, parents, and staff to realize that they are better together. Harlan envisions neighborhood schools where the school and neighboring homes coexist and support each other.

MARCH

03/26/10 — NEW COMMISSIONER APPOINTED

New commission member Daniel Ropp was appointed to the Human Relations Commission.

03/26/19 — TOM JOHNSON OF PFLAG

Johnston passed out PFLAG brochures and gave the history of the national organization and the Corvallis/Albany chapter. He shared the events the organization takes part in and its mission of support, education, and advocacy so that those who identify themselves as LGBTQ+ can live with dignity and respect. Johnston noted that the area's chapter meets mainly in Corvallis but would like to start holding more meetings in Albany. He described the meetings as being a safe place.

Johnston shared about a LGBTQQIP youth group they host called Out-N-About, which wasn't very successful until some OSU grad students got involved. Johnston said that he knows these

efforts are saving lives.

APRIL

04/12/19 — AFRICAN AMERICAN YOUTH LEADERSHIP CONFERENCE

Commissioner Equinoa attended the African American Youth Leadership Conference and reported that the event was well attended. Youth were challenged to identify what was happening to their fellow students, what needed changing in their schools, and how to bring about that change. Equinoa was impressed with the youth who participated.

MAY

05/23/19 — HUMAN RELATIONS AWARD PRESENTATIONAWARDS

Members of the commission presented the awards to the finalist in each category. Elizabeth Pakravan was presented with the Individual HRC Award and South Albany Community Church was presented with the Business/Oranization HRC Award.



JUNE

06/22/19 — PRIDE MARCH

Members of the commission attended the Albany Pride March in support of LGBTQ+ members of the community.

06/25/19 — SUNRISE PARK UPDATE

Commissioner Equinoa, who is the Human Relations Commission representative on the Community Development Commission, reported that Sunrise Park's summer dedication will be delayed due to higher than anticipated project completion bids. After reallocating some community development funds and combing them with some funds from the Parks & Recreation Department, staff is hopeful that the project will be completed in the fall. The wetland approval for the project will expire in the fall, so it is important to complete it by then.



JULY

07/12/19 — LIGHTS FOR LIBERTY

Members of the commission volunteered and attended the Lights for Liberty vigil to bring awareness and to protest the inhumane conditions refugees face in human detention camps.

AUGUST

08/06/19 — NATIONAL NIGHT OUT

Each of the commissioners attended their neighborhoods National Night Out event and drove around to several other neighborhood events to check in with members of the community.

SEPTEMBER

09/11/19 — 9/11 MEMORIAL CEREMONY

Commissioners Jo Rae Perkins and Stephanie Newton attended the 9/11 Memorial Ceremony held at the Linn County Courthouse.

09/15/19 — FESTIVAL LATINO

Commissioner Chris Equinoa volunteered at Festival Latino and Commissioners Brockgreitens and Newton attended and connected with the community. Despite the terrible weather, a few hundred people attended this event.



OCTOBER

10/22/19 — HRC <> HAC JOINT MEETING

Discussed respective missions and how the Human Relations Commission could better support the Hispanic Advisory Commission.

NOVEMBER

11/19/19 — FIRE CHIEF SHANE WOOTON

New Fire Chief Shane Wooton introduced himself to the group. Wanting to have a connection with this commission and the other city organizations, he is attending the different meetings and explaining the mission of his department and his desire to focus on its values of community service.

Chief Wooton invited the Human Relation Commission to let him know of any concerns they have. The group asked about outreach to the community, diversity of the department, budget shortfalls, and how they can support the department. Wooton expressed his desire to be a fire chief that is out in the community.

DECEMBER

12/17/19 — SETTING COMMISSION PRIORITIES AND ACTIONS

The commission's desire is to have a greater positive impact on the community. They decided to focus on inviting community resource agencies to the coming year's HRC meetings.

Commissioner Stephanie Newton said she would reach out to some of the organizations including Jackson Street and Communities Helping Addicts Negotiate Change Effectively (CHANCE) to invite them to come present to the commission at an upcoming meeting so members of the commission can become more knowledgable of the resources and services available to the community.

Commission Established

Council adopted Ordinance No. 5665, March 28, 2007, creating Albany Municipal Code Chapter 2.25, establishing the Human Relations Commission (HRC).

Council adopted Ordinance No. 5671, May 9, 2007, amending AMC 2.25.020 [commissioners must reside within the Albany city limits and 2.25.030 [initial terms to be staggered according to the appointee's surname beginning with three-year terms for those closest to the beginning of the alphabet].

Council adopted Ordinance No. 5866, January 13, 2016, amending AMC 2.25.030, Term of office and initial appointment, removing the following restriction: Members may not serve more than six consecutive years on the Commission. After serving six consecutive years, a member must leave the Commission for one year before being eligible for reappointment.

Purpose

The Human Relations Commission is established by the Albany City Council to strengthen connections within Albany's diverse community by being committed to the philosophy of inclusion, equal opportunity, fair treatment for all residents of Albany and promoting harmonious relations among the citizens of Albany. It is created to recommend programs, activities, ordinances, expenditures, and other appropriate governmental activities which will serve the goal of maintaining respectful interactions within our community.

Duties & Responsibilities

The Human Relations Commission shall meet periodically in public sessions at dates, times, and places as may be established by the Commission. The Commission shall have the duty to make recommendations to the City Council and the City Manager as outlined in AMC 2.25.010.

In formulating its recommendations, the Human Relations Commission shall strive for actions that lead to positive and respectful relations committing to diversity, equity, and inclusion in the community. The duties of the Commission will not include the investigation or sanctioning of individual acts of unlawful or discriminatory behavior but will, instead, focus on recommending community activities that may be expected to promote positive change. The duties of the Human Relations Commission may be revised at any time, after public notice, by resolution.
