

Ordinance No. 234.

An Ordinance to adopt the report and plat of the City Surveyor, W. B. Barr of his survey of a certain street in the City of Albany Oregon, which the Council of said City deem it expedient to lay-out and establish, described as follows: "Beginning at the south west corner of block 202 in the City of Albany Linn County Oregon, and running thence northerly and parallel with the west line of said block 2, 302, 83 feet; thence northerly on an angle of twenty-seven degrees and thirty-five minutes, east with said western boundary 230 feet; thence westerly at an angle of 90 degrees 66 feet; thence southerly at an angle 90 degrees 230 feet to a point on a line with the western boundary of Calapooia street; thence southerly and parallel with Calapooia street 337, 17 feet to a point on a line with the northern boundary of First street; thence parallel with First street 66 feet to the place of beginning;

Whereas on the 14<sup>th</sup> day of September 1891, the Common Council of the City of Albany Linn County Oregon made and adopted the following resolution and Order; "Whereas in the judgment of the Council it is expedient to lay out and establish a street from the north terminus of Calapooia Street in the City of Albany Oregon to the center of the Willamette River on the northern boundary of the said city; Therefore it is resolved by the Council that the Surveyor of said city be and he is hereby directed to survey said proposed new street and to mark the boundaries thereof and to make his report to the Council containing a plat of his survey of said street and a full and perfect description thereof and of the boundaries thereof and of the portion of each lot or part thereof

of each parcel of ground or part thereof to be appropriated for said Street.

And whereas said city Surveyor W. B. Barr has made said survey as in said resolution, and order directed, and has filed his report and plat thereof with the Recorder of said city; Therefore

The People of the City of Albany do ordain as follows;

Section 1. That the said report, and plat of said city Surveyor W. B. Barr of his said survey of said Street, which said report and plat is as follows; "Albany Oregon September 22, 1891"

"To the Honorable Mayor and council of the City of Albany;

Gentlemen in accordance with the resolution No 22 Said Resolution having been adopted by the council at a meeting held the 14th day of September, 1891. I would respectfully report the following as necessary for the

purpose of a public Street in said city <sup>beginning at the south west corner of Block 2. in the city of Albany</sup> ~~of Albany Lane County Oregon,~~ <sup>and running</sup>

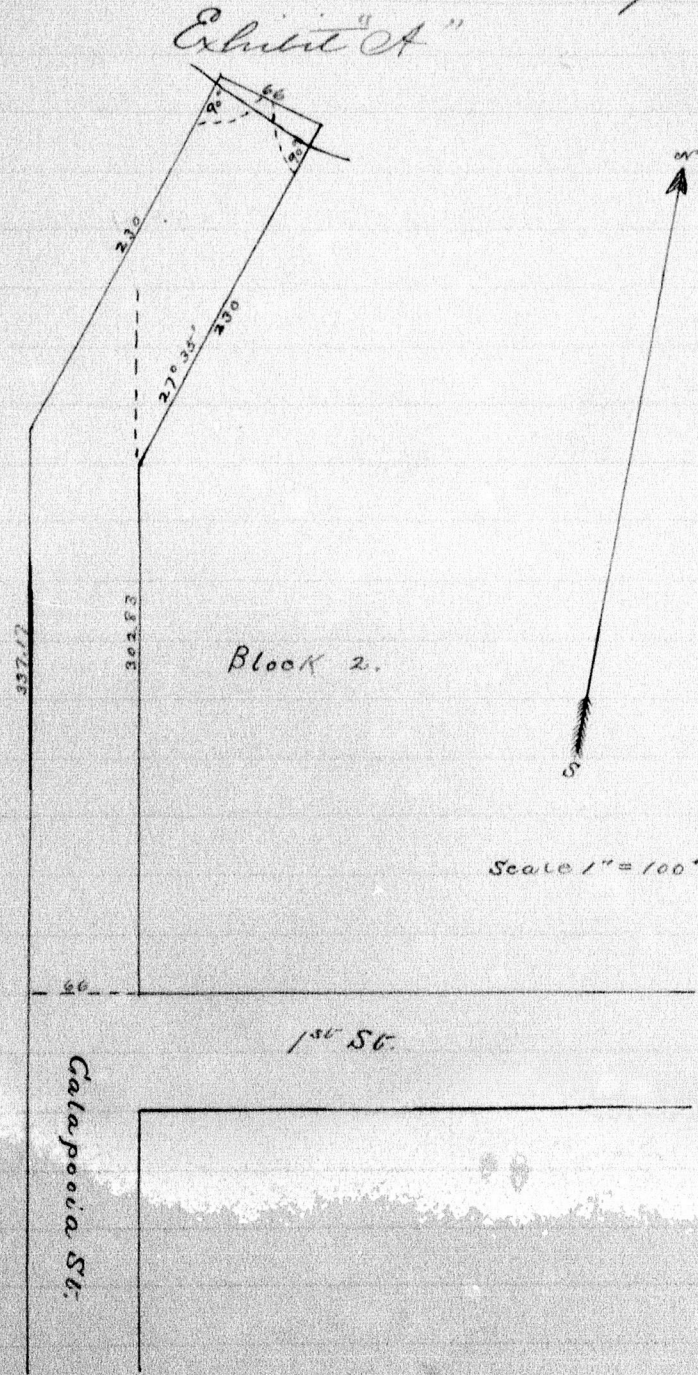
thence northly, and parallel with the Western boundary of "said Block 2. 302.83 feet thence northly, and on an angle of 27 degrees and 30 minutes East with said Western boundary 230 feet; thence Westly at an angle of 90 degrees 66 feet; thence Southly at an angle of 90 degrees 230 feet to a point on a line with the Western boundary of Calapovia Street; thence southly and parallel with Calapovia street 337.17 feet to a point on a line with the northern boundary of first street; thence parallel with first street 66



"fit to the place of beginning; and that I have made a survey of the above, and have caused stakes to be set at the several corners and that I have made a plat of said survey of said street, and that the above is a full and perfect description of said street" as surveyed by me, and of the boundaries thereof, and of the portion or parcels of ground necessary to be appropriated, for said street, the parcel of ground over which said proposed new street" passes not being divided into blocks or lots; the said plat is hereto attached marked exhibit A.

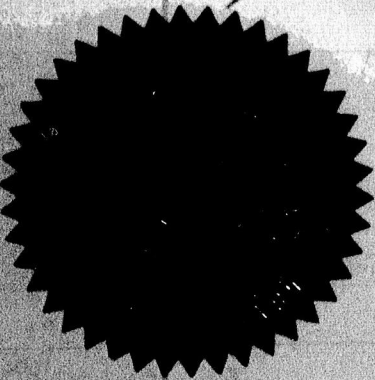
