

Ordinance No 226.

Ord 226
 An Ordinance appointing S. M. Pennington, W. C. Read and J. B. Congill as commissioners to meet and view, the following described Street deemed expedient by the Council to be laid out and established in the City of Albany Oregon; Beginning at the South West corner of Block 2, in the City of Albany Linn County Oregon, and running thence Northerly, and parallel with the West line of said Block 2, 302.83 feet; thence Northerly and in an angle of 27 degrees and 35 minutes East with said Western boundary 230 feet; thence westerly at an angle of 90 degrees, 66 feet; thence southerly at an angle of 90 degrees 230 feet to a point on a line with the Western boundary of Calapooia Street; thence southerly and parallel with Calapooia street, 337.17 feet to a point on a line with the Northern boundary of First Street, thence parallel with First Street 66 feet to the place of beginning, and assigning, and fixing a day and place for said viewers to meet, and directing the Marshall of said City, to give notice of the appointment and time, and place of meeting of said viewers, and of all other matters and things required by Section 76 of the Charter of said City, in regard to laying out and establishing of streets over private property in said City of Albany.


The People of the City of Albany do Ordain as follows

Section 1. That S. M. Pennington, W. C. Read and J. B. Congill all three of said persons being disinterested freeholders of the City of Albany Oregon, and no kin to any

owner or person interested in any property to be appropriated for the proposed new street mentioned, and described in this ordinance, and are possessing the qualifications of jurors of the Circuit Court of the County of Linn in the State of Oregon and they are hereby appointed assessors to meet and view the following described proposed new street, in the City of Albany Oregon; "Beginning at the south west corner of Block 2. in the City of Albany Linn County Oregon, and running thence northward and parallel with the West line of said Block 2. 302.83 feet; thence northward and on an angle 27 degrees and 35 minutes East with said Western boundary 230 feet; thence westward at an angle of 90 degrees, 66 feet; thence southward at an angle of 90 degrees, 230 feet to a point on a line with the Western boundary of Calapooia Street; thence southward and parallel with Calapooia Street, 337.17 feet to a point on a line with the northern boundary of First Street; thence parallel with First Street 66 feet, to the place of beginning" and to assess and determine how much less valuable if any, any lands, tenements, hereditaments or premises or any part thereof, through or over which, or any part of which, said proposed new street, is to be laid out, and established will be rendered, by the laying and establishing thereof, and to make a just and equitable estimate and assessment, of the value of the benefits and advantages, of said proposed new street, to be laid out and established to the respective owners, lessors and other persons interested in any lands, tenements, hereditaments, and premises, any part of

which is required for the opening, laying out or establishing of said proposed new street, in excess of the damages which any such owner, lessee or other person interested will sustain by reason of the opening, laying out and establishing of said new street, and the value of the benefit, and advantage of such street to the respective owners, lessees or other persons interested in any lands, tenements, hereditaments and premises along the line of said proposed new street, or any street or streets connecting therewith, or running in the same general direction not required for the purpose of opening, laying out, or establishing of said new street, but fronting or to front them, or being at or within half the distance of the next street on which side thereof, and which, said viewers shall deem to be benefited by said proposed new street, in respect to the respective estate and interest of such owners, lessees and other persons respectively so interested in any lands, tenements, hereditaments and premises.

Section 2. That Monday the 20 day of October, 1891 at the hour of 10 o'clock A.M. of said day, is hereby assigned and fixed as the time, when the viewers mentioned in section 1. of this Ordinance, shall meet at the Chambers of the City Council in the City of Albany Oregon, and take an oath to faithfully discharge the duties assigned them by this Ordinance.

Section 3. And it is hereby made the duty of the Marshall of said City, and

he is hereby ordered and directed to forth
 with give notice of the appointment of
 said jurors, and of the time, and
 place assigned, and fixed by Section
 2, of this ordinance for them to meet
 and of all other things, and matters
 appertaining to the appropriation of any
 of the property over which, said proposed
 Street passes, as required by section 96
 of the Charter of said City by publishing
 such notice at least once a week for
 four consecutive weeks in some news
 paper of general circulation, published
 in said City of Albany.

Section 4. This Ordinance shall be in
 full force, and effect from and
 after its approval by the Mayor.


