

Ordinance No 238.

*No. 238*  
An Ordinance relating to establishing the grade, depth, and location of lateral sewers to connect the following named blocks in the City of Albany Oregon, with the main sewer in Perry street from the Willamette river to the Southern boundary line of said City, to-wit: Blocks 1-2-3-4-5-6-7-8-9-10-11-12-13-14-15-16-17-18-19-20-21-22-23-24-25-26-27-28-29-30-31-32-33-34-35-36-45-46-47-48-49-50-51-52-53-54-55-56-65-66-67-68-69-70-73 in the City of Albany Oregon, and blocks 74-75-76-77-78-89-90-91-92-93-94-98-99-100-101 and 102 in Monteith Southern Addition to said City of Albany.

The people of the city of Albany do ordain as follows:

Section 1; That the established grade, depth and location of the lateral sewers to connect the following named blocks in the City of Albany, Oregon with the main sewer in Perry street, from the Willamette river to the Southern boundary line of said City, to-wit: Blocks 1-2-3-4-5-6-7-8-9-10-11-12-13-14-15-16-17-18-19-20-21-22-23-24-25-26-27-28-29-30-31-32-33-34-35-36-45-46-47-48-49-50-51-52-53-54-55-56-65-66-67-68-69-70-73 in the City of Albany, Oregon, Oregon, and blocks 74-75-76-77-78-89-90-91-92-93-94-98-99-100-101 and 102, in Monteith, Southern addition to said City of Albany, shall be in conformity to the survey, plans, profile thereof, made by City Surveyor Barr, in the year 1892, and filed in the Office of the Recorder of said City on the 10<sup>th</sup> day of March 1892, And the lateral sewers hereafter to be constructed, connecting each of said blocks hereinbefore described and named with the main sewer in said Perry Street, shall be on the grade, at the depth, and in the location, as designated and shown by said Survey, plans, and profile thereof, filed in the Office of the Recorder of said City on the day and year above written.

Section 2. All ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 3. This ordinance shall take effect, and be in full force from and after its approval by the mayor.
