

Ordinance No 244.

Ord. 244

An ordinance adopting certain reports of surveys of the City Surveyor which said report and survey shows the boundary and description and plat of the parts of Block No 45 in the City of Albany Linn County Oregon and the parcels of land therein contained necessary for a right of way for the construction and maintaining of a sewer over and across said block. Said survey and the report thereof having been filed with the Recorder of said City on the 7th day of May 1892

Whereas the Common Council of the City of Albany did on the 16th day of April 1892 declare by Resolution No 24 that it is necessary and expedient to lay and construct a sewer over and across Block No 45 in the City of Albany Oregon at or near the center of said block and in a direction running parallel with the north boundary line of said block and the parcels of land therein over and across which said sewer is proposed to be constructed being private property, and

Whereas said Council did on said 16th day of April 1892 direct and order the Surveyor of said city to survey and make a full and perfect description and plat of the boundaries of such proposed sewer and the portions of said block and the parcels of land therein necessary to be appropriated as and for a right of way for such sewer, and to mark the boundaries of such sewer and parcels of land required for a right of way for the laying and constructing of such sewer and to report such survey in writing to said Council, And,

Whereas said Surveyor did make such survey as so directed by said Resolution

and on the 5th day of May 1892 did make his report in writing to said Council of his survey and descriptions of a right of way for a sewer over and across said block in the City of Albany and of the portion of the parcels of land in said block necessary for a right of way for the construction of a sewer over and across said block and did append to said report a correct plat of said survey showing the particular portions of said block and the respective parcels of land therein required for the right of way necessary for the constructing and maintaining of such sewer over and across such portions of said blocks and parcels of land therein, therefore

The People of the City of Albany
do ordain as follows.

Section 1 That the said report of said City Surveyor of his said survey of a right of way for a sewer over and across Block No 45 in the City of Albany Linn County Oregon which said original report is as follows, be and the same is hereby in all things approved and adopted

Albany Oregon May 7th 1892

To the Honorable Mayor and Council of the City of Albany
In accordance with Resolution No 24 said resolution having been adopted by the Council at a meeting thereof held on the 16th day of April 1892 I most respectfully report to you that I have made the following survey in block No 45 in the City of Albany Linn County

Oregon as directed to be made by said resolution No 24 and hereby report that it is necessary to appropriate the following described parcels of land situated in said block for a right of way for the construction of a sewer over and across said block, to-wit,

Beginning at a point on the Western boundary of block 45 in the City of Albany Linn County Oregon 101 feet from the North west corner of said block and running thence easterly and parallel with the Northern boundary of said block 67 1/24 feet thence southerly and parallel with the western boundary of said block 10 feet thence westerly and parallel with the southern boundary of said ^{block} to the western boundary of said block thence northerly and along said western boundary to the point of beginning, also,

Beginning at the center of block 45 in the City of Albany Linn County Oregon and running thence westerly and parallel with the Northern boundary of said block 67 1/24 feet thence northerly and parallel with the western boundary of said block 10 feet thence easterly and parallel with the southern boundary of said block 67 1/24 feet thence southerly to the point of beginning, also.

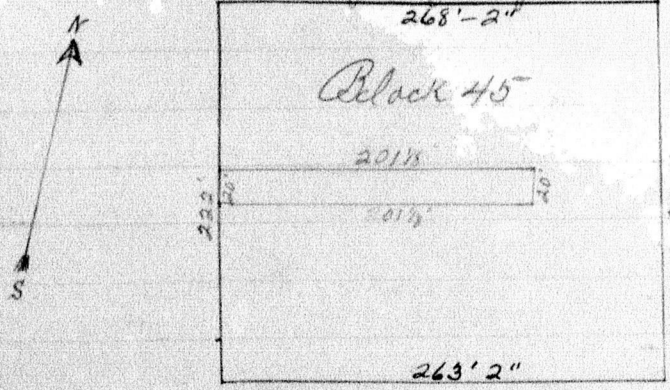
Beginning at the center of block 45 in the City of Albany Linn County Oregon and running thence northerly and parallel with the eastern boundary of said block 10 feet thence easterly and parallel with the northern boundary of said block 67 1/24 feet thence southerly and parallel with the eastern boundary of said block 20 feet thence westerly and parallel with the southern boundary of said block 67 1/24

feet thence northerly to the point of beginning, also.

Beginning at a point on the western boundary of block 45 in the City of Albany Linn County Oregon and 101 feet from the south west corner of said block and running thence easterly and parallel with the southern boundary of said block 134 1/2 feet thence northerly and parallel with the eastern boundary of said block 10 feet thence westerly and parallel with the northern boundary of said block to the western boundary of said block thence southerly and along said western boundary to the point of beginning, and that the following is a description of the required right of way for the construction of a sewer over and across said block.

Beginning at a point on the western boundary of block 45 in the City of Albany Linn County Oregon 101 feet from the north west corner of said block and running thence easterly and parallel with the northern boundary of said block 201 1/8 feet thence southerly and parallel with the eastern boundary of said block 20 feet thence westerly and parallel with the southern boundary of said block to the western boundary of said block thence northerly and along said western boundary to the point of beginning
