

Ordinance No 250

An ordinance to amend section (1) one of ordinance number 235, entitled "An Ordinance to Amend Section (1) one of Ordinance Number 202" approved by the Mayor October 21st 1890 entitled "An Ordinance to amend Section (1) one and three (3) of Ordinance Number 201. Passed by the Council July 27th 1890 and approved by the Mayor August 1st 1890, entitled "An Ordinance to Amend Sections (1) one and (3) three of ordinance number 180 Passed by the Council June 26th 1888" entitled "An Ordinance to amend Sections (1) one and (3) three of an Ordinance relating to the establishing of Grade for Streets in the City of Albany" passed by the Common Council December 14th 1876.

The People of Albany do ordain as follows.

Section 1. That Section (1) one of ordinance number 235 entitled "An ordinance to Amend Section (1) one of ordinance number 202, approved by the Mayor October 21st 1890 entitled An ordinance to amend Sections (1) one and (3) three of ordinance number 201 Passed by the Council July 27th 1890 and approved by the Mayor August 1st 1890 entitled "An ordinance to Amend Sections (1) one and (3) three of ordinance number 180 Passed by the Council June 26th 1888, entitled, an ordinance to amend Sections (1) one and (3) three of an ordinance, entitled "An Ordinance Relating to the Establishing of Grade of Streets in the City of Albany Passed by the Common Council December 14th 1876 be amended so as to read as follows.

Section 1. The established grade of the streets of the City of Albany Linn County Oregon.

from the east line of Vine street to the west
 line of Thurston street, and from the north
 line of Water street to the south line of Ninth
 street shall be in conformity to the survey and
 plat made by Surveyor Warner in the year 1876
 and now on file in the office of the Recorder
 of the City of Albany Oregon save and except
 that the established grade of Baker street
 and Montgomery street between Fourth street
 and Seventh street and the established grade
 of Fifth street Sixth street and seventh street
 between Lyons street and Railroad street, shall
 be in conformity to the survey and plat made
 by Surveyor W. C. Carr in the year 1888 and
 adopted by the Common Council June 12th 1888
 and now on file in the office of the City
 Recorder and also further except that the
 established grade of Second street Third street
 and Fourth street from the east line of
 Vine street to the west line of Washington street
 and of Calaveria street from the north line
 of Second street to the north line of Fourth
 street shall be in conformity to the survey
 and plat made by J. A. Warner in the year
 1890 and adopted by the Common Council
 July 8th 1890 and now on file in the office
 of the Recorder of said City and also further
 that the established grade of Fourth street
 between Baker street and Railroad street
 be in conformity to the survey and plat
 made by J. A. Warner in the year 1890
 and adopted by the common Council October
 14th 1890 and now on file in the office
 of the Recorder of said City and also
 further except that the established grade of
 Calaveria street from the north line of
 First street to the north line of second
 street, and of First street from the west line
 of Washington to the west line of Calaveria


street be in conformity to the survey and plat made by City Surveyor W. B. Barr in the year 1892 and filed in the office of the Recorder of said City of Albany on the 5th day of February 1892 and adopted by ordinance number 255 February 9th 1892 and also further except that the established grade of Calabaria street from the south line of First street to the north line of Fourth street shall be in conformity to the survey and plat made by City Surveyor W. B. Barr in the year 1892, and filed in the office of the Recorder of said City on the 31st day of May 1892

Section 2 All ordinance or parts of ordinances in so far only as they are in conflict with this ordinance are hereby repealed

Section 3 This ordinance shall take effect and be in full force from and after its approval by the Mayor.
