

Ordinance No 251

An Ordinance adopting certain reports of certain surveys made by H B Barr the City Surveyor of the City of Albany Linn County Oregon in pursuance of Resolution No 28 adopted by the Council of said City on the 14th day of June 1892, which said reports and surveys show the boundaries descriptions, and plats of the parts of Blocks Nos 117, 118, 119, 120, 121 and 122 in Hackleman's Addition to the City of Albany Linn County Oregon and the parcels of land therein contained necessary for rights of way for the constructing and maintaining of a lateral sewer over and across each of said blocks, Said reports of such surveys having been filed with the Recorder of said City on the 28<sup>th</sup> day of June 1892

Whereas the Common Council of the City of Albany did on the 14 day of June 1892 declare by Resolution No 28 that it is necessary and expedient to lay and construct a sewer over and across Block No 117 in Hackleman's Addition to the City of Albany Oregon at or near the center of said block and in a direction running parallel with the north boundary line of said block and the parcels of land therein over and across which said sewer is proposed to be constructed being private property and also that it is expedient to lay and construct a sewer over and across Block No 118 in Hackleman's Addition to said city of Albany at or near the center of said block and running in a direction parallel with the north boundary line thereof said block and parcels of land therein over and across which it is proposed to construct said sewer being private property, and

Whereas said Council did on the 14th day

of June 1892 declare by Resolution No 28 that it is  
expedient to lay and construct a sewer over  
and across Block No 119 in Hacklemans  
Addition to said City at or near the center  
of said block and running in a direction  
parallel with the north boundary line  
thereof said block and the parcels of land  
over which it is proposed to construct such  
sewer being private property and also that  
it is expedient to lay and construct a sewer  
over and across block No 120 in Hacklemans  
Addition to said city at or near the center  
thereof and running in a direction parallel  
with the north boundary line of said block  
said block and the parcels of land therein  
over which it is proposed to construct  
such sewer being private property and  
also that it is necessary and expedient  
to lay and construct a sewer over and  
across Block No 121 in Hacklemans.

Addition to said City of Albany at or near  
the center of said block and running in  
a direction parallel with the north  
boundary line thereof said block and  
the parcels of land therein over and across  
which it is proposed to lay and construct  
such sewer being private property. And

Whereas said Council did on said 14<sup>th</sup> day  
of June 1892 direct and order the Surveyor  
of said city to survey and make a full

and perfect description and plat of the boundaries of such respective proposed sewers and the portions of said blocks respectively and the parcels of land therein necessary to be appropriated as and for a right of way for such sewers respectively and to mark the boundaries of such sewers and parcels of land required for rights of way for the laying and constructing of each of such sewers and to report such sewers respectively in writing to said council  
And Whereas said Surveyor did make such surveys as so directed by said Resolution and on the 28<sup>th</sup> day of June 1892 did make his report in writing to said Council of his surveys and descriptions of a right of way for a sewer over and across each of said blocks in the City of Albany and of the portion of the parcels of land in said blocks necessary for a right of way for the construction of a sewer over and across each of said blocks and did append to each of said reports a correct plat of each of said surveys showing the particular portions of each of said blocks and the respective parcels of land therein required for the respective rights of way necessary for the constructing and maintaining of each of such sewers over and across such portions of said blocks and parcels of land therein, therefore

The People of the City of Albany do ordain as follows:




