Ordinance No. 311.

Ord. No. 311 An Ordinance declaring the probable cost of improving that part of Ninth Street in the City of Albany, ^{Oregon} from the East line of Montgomery Street, to the West line of Jefferson Street in said City, and ascertaining, and determining the proportionate share of such cost, to be borne by, and assessed against each lot, or part thereof abutting on said portion of Ninth Street, proposed to be improved, and directing the City Recorder to enter a statement thereof in the Docket of City Liens.

The People of the City of Albany do ordain as follows:

Sections That there be, and is hereby assessed on each of the following described lots, and parts of lots, lying, and abutting on Ninth Street, between the East line of Montgomery Street, and the West line of Jefferson Street, in the City of Albany, the amounts hereinafter set out, and indicated, the same being the proportionate share of the probable cost of said improvement to be borne by said lots, and parts of lots, respectively, to-wit:

Lot 5, block 18, in Hackleman's 2nd addition to the City of Albany, owned by Geo. W. Harris \$1.50; the East 114 feet of lot 6, block 18, Hackleman's 2nd to the City of Albany, owned by Geo. W. Harris \$2.03; the West 52 feet of lot 6, in block 18, Hackleman's 2nd addition, to the City of Albany, owned by Mrs. A. Q. Rankin, \$8.00; Lot 7, in block 18, Hackleman's 2nd addition to the City of Albany, owned by Mrs. Elizabeth Gross \$10.40; Lot 8, in block 18, Hackleman's 2nd addition to the City of Albany, owned by Mrs. Elizabeth Gross \$10.40; Lot 5 in block 19, in Hackleman's 2nd addition to the City of Albany, owned by the Oregon, Oregon, and California Railroad Company, \$9.20; Lot 6, in block 19, in Hackleman's 2nd addition to the City of Albany,

owned by the Oregon, and California Railroad Company, #9,20; Lot 7, in block 19, in Hackleman's 2nd addition to the City of Albany, owned by the Oregon, and California Railroad Company, #9,20; Lot 8, in block 19, in Hackleman's 2nd addition, to the City of Albany, owned by the Oregon, and California Railroad Company, #9,20; Lot 5, in block 7, in Hackleman's 2nd addition to the City of Albany, owned by the Oregon, and California Railroad Company, #787; Lot 6, in Block 7, in Hackleman's 2nd addition to the Oregon, and California Railroad, #7,32.

Section 2: The Recorder of the City of Albany, is hereby directed to enter a statement of the foregoing assessments in the docket of City liens, in accordance with the provisions of Section 69, Chapter 7, of the Charter of the City of Albany.

Section 3: This Ordinance shall take effect, and be in full force from, and after its approval by the Mayor.
