

Ord No. 357 An Ordinance authorizing the building and laying of a sidewalk six feet in width in front of and adjacent to the North line of lots 1 and 2 and the West half of lot 3 in Block 12 in the Eastern Addition to the City of Albany, Oregon, and to authorize the Mayor and Recorder of the City of Albany to enter into a contract on the part of the City of Albany for the construction of the same, and providing for the cost and expense of the building and laying of said sidewalk to be assessed to the holders and owners of lots and parts of lots abutting and adjoining said sidewalk.

The People of the City of Albany do ordain as follows:
 Section I. - That there be constructed on the North side of lots one and two and the West half of lot 3 in Block 12 in the Eastern Addition to the City of Albany Oregon, a sidewalk six feet in width, in front of and adjacent to said lots on the North side thereof, and that the Mayor and Recorder of the City of Albany are hereby authorized, directed and empowered to enter into and sign on the part of the City of Albany, within articles of agreement for the construction and laying of the sidewalk six feet in width along the North line of lots 1 and 2 and the West half of lot 3 in Block 12 in the Eastern Addition to the City of Albany, Linn County, Oregon; the same being on the South side of Fourth Street of said City. That the cost of the construction and laying and building of said sidewalk be assessed to the several owners and holders of lots or parts of lots abutting on and adjacent to said sidewalk when constructed, Provided that such contract shall not be entered into and such articles of agreement signed by the Mayor and Recorder on the part of said City until after the proposals for the construction of the said sidewalk has been advertised for in the manner provided for by the City charter and ordinances regulating and awarding of contracts and bids have been received and considered by the Council, and the contract awarded by the Council, and the cost and expense for constructing said sidewalk fixed and determined.

ORDINANCE NO. 351

Section II.- This ordinance shall take effect and be in full force from and after its approval by the Mayor. Approved this 24th day of July 1901
