An Ordinance to regulate the removal and transportation of swill or garbage during certain hours, within the corporate limits of the City of Albany, and providing a penalty for violation thereof.

The People of the City of Albany do Ordain as follows:-

Sec. 1:- That no person or persons shall remove, transfer or transport any swill or garbage, through any public street, place or alley within the corporate limits of the City of Albany, except it be in a tightly covered box, or apparatus, or in such a manner as will prevent the contents thereof being deposited in the public streets, alleys or places, or from being exposed in the open air during such process of transportation; provided further, that no person or persons removing, transferring or transporting any swill or garbage as hereinabove provided shall permit his horse, team or wagon, to remain in any public street, place or alley for any longer period than is actually necessary to collect said swill or garbage and empty the same into the box or other apparatus in which it is to be removed.

Sec. 2:- That no person or persons, shall remove, transfer, or transport any swill or garbage through any public street, place or alley within the corporate limits of the city of Albany, except between the hours of eight o'clock evening and nine o'clock forenoon following, during the months of April, May, June, July, August and September, and between the hours of four o'clock afternoon and ten o'clock forenoon following during the months of October, November, December, January, February and March,

Sec. 3:- Any person or persons violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof before the Recorders Court, shall be fined not less than five dollars (\$5.00) nor more than one hundred dollars (\$100.00) or imprisoned in the city jail not less than two (2) days nor more than twenty (20) days, or both such fine and imprisonment, at the discretion of the Court.

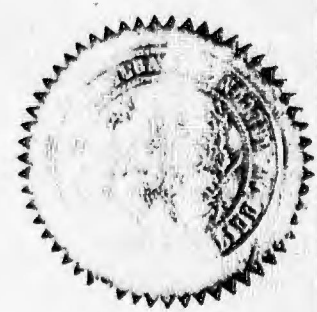
Sec. 4:- This ordinance shall be in full force.
