An Ordinance changing and establishing the grade of all that portion of Elm Street in the City of Albany, Oregon, between the centerline of 7th Street and the center line of 8th Street, and all that portion of the grade on 5th Street in said City, between the West line of Walnut Street and the East line of Elm Street; and all that portion of 6th Street grade, between the West line of Walnut Street and the East line of Elm Street, so as to conform to the survey of the grade of said portion of said Elm, Fifth and Sixth Streets as made by, and shown by the survey and plat thereof made by J. A. Warner, City Engineer, and filed in the office of the Recorder of the City of Albany, on the 10th day of March, 1908, and to repeal all Ordinances or parts of Ordinances in Conflict herewith.

The People of the City of Albany do Ordain as follows:

Section 1. That the grade of all that portion of Elm Street between the centerline of seventh street and the center line of Fifth Street, in the City of Albany, Oregon, and all that portion of the grade of Fifth Street in said City between the West line of Walnut Street and the East line of Elm Street and all that portion of the grade of Sixth Street, between the West line of Walnut Street and the East line of Elm Street, in said City, be and the same is hereby changed and established so as to conform to the survey of the grade of said portion of said Elm, Fifth and Sixth Streets, as shown and made by the survey and plat thereof, of City Engineer J. A. Warner, made in the year 1908, and filed in the Office of the Recorder of said City, on the 10th day of March A.D. 1908.

Section 2. All Ordinances or parts of Ordinances in Conflict herewith are hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after thirty days from its approval by the Mayor.
