An Ordinance authorizing the building and construction of a Cement Curbing, Eighteen inches in depth, adjacent to, and parallel with, and twelve feet from the West line of Lot 1, and part of Lot 8, in Block # 2, in the Eastern addition to the City of Albany, Linn County, Oregon, at the cost of the owner or owners of said real property, and authorizing the Mayor and Recorder of said City to enter into a Contract for the Construction of the same;

The People of the City of Albany do ordain as follows:

Section 1. That there shall be built and constructed a cement curbing, Eighteen inches in depth, adjacent to, and twelve feet from, and parallel with the West line of Lot No. 1, and part of Lot 8, in Block No. 2, on the East side of Lyon Street, in the Eastern addition to the City of Albany, Linn County, Oregon, said curbing to be constructed in all particulars according to the surveys and specifications for the curbing in said streets now on file in the Office of the City Recorder for the City of Albany, Oregon.

That the cost of ^{the} construction and completion of said curbing shall be assessed to the owners and holders of lots and parts of lots in said Block Three in said City of Albany, adjacent thereto, and benefited thereby, as their respective interests may appear; Provided, That such contract shall not be entered into, or such articles of agreement signed by the Mayor and Recorder on the part of the City of Albany until after proposals for the construction of said cement curbing has been advertised for in the manner provided by the City Charter, and ordinances of said City regulating and awarding contracts, and bids have been received and considered by the Council and the contract awarded by the Council, and the cost and expenses for constructing said curbing have been fixed and determined.

Section 2. This Ordinance shall take effect and be in full force from and after thirty days from its approval by the Mayor,
