

ORDINANCE NO. 475

Sidewalk & Curb, E. side Lot 5, Blk 3

Ord 475
Sidewalk
to be

An Ordinance authorizing the Construction of
a cement sidewalk ten feet in width with curb adjacent
to and abutting the East line of Lot No. 5, Block No. 3, on
the West side of Ferry Street, in the City of Albany,
Lincoln County, Oregon.

The people of the City of Albany do ordain as follows:

Section 1. That there shall be constructed a cement
sidewalk ten feet in width with curb adjacent
and abutting the East line of Lot 5, in Block No. 3, on
the West side of Ferry Street, in Albany, Lincoln County,
Oregon at the cost and expense of the owners
of said real property, and that the Mayor and
Recorder of said City of Albany, be and they are
herby authorized, directed and empowered to
enter into, and sign on behalf of said City of Albany
written articles of agreement for the construction of
said sidewalk and curb. Provided, that said
contract shall not be entered into, or said articles
signed by the Mayor and Recorder on the part
of the said City, until after the proposals for the
construction of said cement sidewalk and curb
has been advertised for in the manner provided
for by the City Charter, and the Ordinances reg-
ulating the manner of awarding contracts,
and bids have been received and considered
by the Council, and the contract awarded by
the Council, and the costs and expenses of
constructing the same have been ascertained,
fixed and determined.

Section 2, That the costs and expenses of the
construction of said sidewalk and curb shall
be made a lien upon the said real property
adjacent to which the same is constructed, to be
levied and enforced in the manner provided
by the Charter and Ordinances of said City.

Section 3. Inasmuch as it is necessary
that a portion of said sidewalk & curb be con-
structed before street paving under contract.

can be successfully completed, an emergency is therefore declared to exist, and this Ordinance shall be in full force and effect from and after its approval by the Mayor
