An ordinance declaring a surplus on account of Street paving by the Warren Construction Company on the Lyon Street Contract and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate abutting upon said Lyon Street and heretofore assessed for making such improvements entered upon the Docket of City Lino of the City of Albany. Or in their proportionate share of such surplus.

The People of the City of Albany do ordain as follows:

Section 1. That a surplus of twelve and one-half per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany and the Warren Construction Company for the improvement of Lyon Street and in favor of each of the several owners of the various parcels of real estate abutting upon said Lyon Street, and heretofore assessed for making such improvement, as their several interests may appear.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Lino, in the surplus column thereof, a credit of twelve and one-half per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of the improvement of said Lyon Street, said surplus being in favor of the following named persons, owners of such various parcels of real estate, in sums following to wit:
