

ORDINANCE NO. 530

Construction of sidewalk and curb on NE 4 Blk #12 Hack. 2nd add.

Ord 530
Construction of sidewalk and curb along and adjacent
to the North and East lines of the Northeast quarter
of block No. 12, in Hackleman's Second Addition
on NE 4 Blk #12 Hack. 2nd add.

An Ordinance authorizing the construction of
cement sidewalk and curb along and adjacent
to the North and East lines of the Northeast quarter
of block No. 12, in Hackleman's Second Addition
to the City of Albany, Oregon, as the same appears
upon the maps and plats of said City, and at
the cost and expense of the owners and holders
of the real property abutting upon and adjacent
to such proposed improvement, and authorizing
the Mayor and Recorder of said City to enter into
a contract for the construction of the same.

The People of the City of Albany do ordain as
follows:

Section 1. That there shall be constructed a cement
sidewalk and curb along and adjacent to the North
and East lines of the Northeast quarter of Block
No. 12 in Hackleman's Second Addition to the
City of Albany, Oregon, as the same appears upon
the maps and plats of said City, at the cost
and expense of the owners and holders of the
real property abutting upon and adjacent to such
proposed improvements, and that the Mayor
and Recorder of said City of Albany, be and
they are hereby authorized and directed to enter
into and sign on behalf of said City of Albany,
written articles of agreement for the construction
of said sidewalk and curb, provided, that said
contract shall not be entered into, or said articles
signed by the Mayor and Recorder on part of
said City, until after proposals for the construction
of said sidewalk and curb has been advertised for in
the manner provided by the City Charter, and
the ordinances regulating the manner of awarding
contracts, and bids have been received and considered
by the Council, and the contract awarded by the
Council, and the costs and expenses of constructing
the same have been ascertained, fixed and determined.

Section 2. That the costs and expenses of the
construction of said sidewalk and curb shall
be made a lien upon the said real property.
