An ordinance to repeal Ordinance 449 entitled "An ordinance granting to G. L. Rauch, his heirs, executors, administrators, and assigns with the right and privilege to supply the City of Albany and the inhabitants thereof with gas for heat, light and power and for the said purpose to construct works and lay pipes in the streets, avenues, alleys and all public places in the said City, and to charge a reasonable price therefor," passed the Council June 6, 1913, and approved by the Mayor June 6, 1913.

Whereas on the 6th day of June, 1913, Ordinance No. 649 of the City of Albany was passed, which ordinance granted a franchise to G. L. Rauch, his heirs or assigns to erect a gas plant and use the streets, alleys and public places of the City of Albany for the purpose of having gas made and distributing said gas to the City of Albany and the inhabitants thereof; and

Whereas one of the conditions of said ordinance was and is that the said grantee should furnish to the City of Albany a good and sufficient bond in the sum of \$5,000.00 to be approved by the mayor for the installation and completion of said gas plant as provided in said ordinance No. 649; and

Whereas the said G. L. Rauch, his heirs or assigns has failed to furnish the said bond to the City of Albany within the time provided in said ordinance No. 649, and has failed to furnish any bond to the City of Albany,

Now therefore in consideration of the premises

The People of the City of Albany Do Ordain as Follows:

Section 1. That Ordinance No. 649, entitled, "An ordinance granting to G. L. Rauch, his heirs, executors, administrators, and assigns with the right and privilege to supply the City of Albany and the inhabitants thereof with gas for heat, light and power and for the said purpose to construct works and lay pipes in the streets, avenues, alleys and all public places in the said city and to charge a reasonable price therefor," passed the Council June 6, 1913, and approved by the Mayor June 6, 1913, and the same is hereby repealed and all rights and privileges granted thereunder to the said G. L. Rauch, his heirs and assigns be and the same are hereby revoked and for aught held.
