

Ord No
725

An ordinance revoking a portion of resolution No. 11 passed by the council the 22nd day of April, 1914, and authorizing and directing the Record of the City of Albany to re-advertise for bids for making the improvement of Wright Street from the 325th side of Pine Street to the 3rd side of Courtney Street.

Whereas the council of the City of Albany passed Ordinance No. 720 on the 20th day of June, 1914, which ordinance was approved by the Mayor on the 26th day of June, 1914, and which ordinance authorized and directed the council to cause a notice for bids for making the improvement of Wright Street from the 325th side of Pine Street to the 3rd side of Courtney Street according to the plans, specifications and estimates of the City Engineer on file in the Recorder's office; and

Whereas said a bid was published and bids received for said work;

Whereas the council of the City of Albany on the 22nd day of April, 1914, passed a resolution declaring said bids unreasonable and authorized and directed the city engineer together with the committee on streets and public property to take work of making said improvement of Wright Street; and

Whereas the council deems it expedient and necessary to revoke said portion of said resolution authorizing and directing the city engineer and committee on streets and public property to do said work of said improvement; and

Whereas the Council of the City of Albany deems it expedient to re-advertise for bids on the closing of said improvement of said portion of Wright Street;

Now Therefore, in consideration of the premises,

The People of the City of Albany do Ordain As Follows

Section 1. That portion of the said Resolution, authorizing and directing the City of Albany to make said improvement of Wright Street under the supervision of the City Engineer do hereby be revoked and the City Engineer together with the committee on streets and public property are hereby authorized and empowered to purchase, purchase, make, and discharge any and all things necessary or convenient in making said improvement and the same to be done.

Albany, Oregon

Section 2. The Recorder of the City of Albany is hereby authorized and directed to re-advertise for bids for the making of said improvement of the said portion of North Street in manner and form as prescribed by the said Ordinance No. 720.
