

ORDINANCE NO. 725

An ordinance revoking a portion of resolution No. 11
passed by the council the 2nd day of April, 1914, and authorizing
and directing the Board of the City of Albany to re-advertise for
bids for making the improvement of Wolf Street from the Cross. St. of
Duanesburg to the 4th Avenue at Montgomery Street.

Whereas the Council of the City of Albany passed resolution No.
720 on the 2nd day of April, 1914, which a license was granted by
the Mayor on the 5th day of April, 1914, to the Board of Engineers, Albany,
and directed them to make a notice for bids for making the improve-
ment of the 4th Avenue, or Wolf Street from the Cross Street to the 4th
avenue, line of 4th Avenue Street according to the plans, specifications
and estimates of the City Engineer made in the Recorder's office;
and

Whereas said a notice was published and bids were
received for said work; and

Whereas the Council of the City of Albany on the 22nd day
of April, 1914, passed a resolution declaring said bids unacceptable
and authorized and directed the City Engineer together with the
Committee on Streets and Public Property to do the work of making
said improvement of Wolf Street; and

Whereas the Council deems it expedient and necessary
to revoke said previous resolution authorizing and bidding
the City Engineer and Committee on Streets and Public Property
to do said work on said improvement; and

Whereas the Council of the City of Albany deems it expedient
to re-advertise for bids for the doing of said improvement of said
portion of Wolf Street;

Now, therefore, in consideration of the premises,

The People of the City of Albany do Ordain As Follows:

Section 1. That the 1st portion of the said Resolution, and
reading as follows: "be it further ordered that the City of Albany
make said improvement of Wolf Street under the supervision of the
City Engineer and the City Engineer together with the Committee
on Streets and Public Property, who are hereby authorized and
empowered to purchase, erect, maintain, repair, purchase, materials,
and equipment necessary for the carrying out of the same and all things
necessary to accomplish the purpose and intent of said Resolution" and the
same is hereby repealed.

Section 2. The Recorder of the City of Albany is hereby authorized and directed to re-advertise for bids for the making of said improvement of the said portion of Ninth Street in manner and form as prescribed by the said Ordinance No. 720.
