

Ord No
746

An ordinance to ascertain, determine and declare the cost of constructing a cement sidewalk on Ninth Street on the South side of and adjacent to the East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon, and to assess such cost and establish a lien upon said land and directing said liens to be entered in the books of the City Clerks.

Whereas on the 8th day of July, 1914, the Superintendent of Streets of the City of Albany reported in writing to the Council that a sidewalk should be built on Ninth Street on the South side of and adjacent to the East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon; and

Whereas the Council on said 8th day of July, 1914, duly passed Resolution No. 44 ordering said sidewalk constructed within twenty days from said July 6, 1914, which resolutions specified the width and location thereof, the material to be used and that the construction should be in accordance with Ordinance No. 468; and

Whereas within five days after the said order to build so made on July 8th, 1914, the Superintendent of Streets did post a notice on said East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon, adjacent to the sidewalk ordered to be built headed "Notice to Build Sidewalk", in letters not less than one-half inch in length and which said notice in legible characters, directed to the owner of said property, Lora Moore to build said sidewalk within twenty days from said July 8th, 1914; and

Whereas the Superintendent of Streets did file with the Recorder an affidavit of the posting of such notice, stating the date when and the place where the same was posted; and

Whereas the Recorder did within five days from said order of July 8th, 1914, send by mail a notice to build said sidewalk to the owner of said property, Lora Moore directed to the post office address of such owner, to-wit: Albany, Oregon, and;

Whereas the owner of said East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon to-wit: Lora Moore, failed, neglected and refused to build such sidewalk within the time ordered by the Council; and

Whereas the Superintendent of Streets has built said sidewalk and kept an accurate account of the cost of labor and material in building said sidewalk adjacent to said land above described and has reported the same as completed to

cost of said sidewalk together with a description of the lot or part thereof or parcel of land fronting on the sidewalk upon which said sidewalk has been built; and

Whereas the council has inspected the said report of said Superintendent of Streets of the construction of said sidewalk and the cost thereof, which cost is the sum of \$51.87; and

Whereas the council deems the same to be reasonable, which said cost is hereby approved.

Therefore:

The People of the City of Albany Do Ordain as Follows:

Section 1. That the cost of building the sidewalk on Ninth Street on the South side of the East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon, was and is the sum of \$51.87;

Section 2. That there be and there is hereby assessed upon the said East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon, for said sidewalk construction the sum of \$51.87 and that the same be and is hereby made a lien upon said premises until the full payment thereof and the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the said assessment and lien together with the name of the owner of said East 44 feet of the Southeast quarter of Block 31, Hackleman's Second Addition to the City of Albany, Oregon, Jora Moore, in the Pocket of City signs of the City of Albany as provided by the Charter of said city, and that the Recorder shall forthwith give notice in writing as provided in Section 223 of the Charter of the City of Albany to the owner or interested owner of said real property.
