

ORDINANCE NO. 183.

Revised Albany Ordnance

No 155

An ordinance to ascertain and determine the probable cost of constructing a lateral sewer, which the council of the City of Albany, Oregon, has determined by Resolution No. 29 adopted by the council on the 26th day of August, 1914, beginning at the west end of lateral sewer constructed through Block 16, across Dennis Street, through the center of Block 15, across Cleveland Street and 40 feet into Block 6, all in Hackleman's Fourth Addition, to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement that is assessed upon each lot or part thereof, adjacent to said improvement, to direct the Recorder of said city to enter a statement of such assessments in the Books of City Liens as provided by the Charter of said City.

Whereas on the 26th day of August, 1914, the council of the City of Albany duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the construction of a lateral sewer beginning at the west end of lateral sewer constructed through Block 16, across Dennis Street, through the center of Block 15, across Cleveland Street and 40 feet into Block 6, all in Hackleman's Fourth Addition and for the estimate of the work to be done and the probable cost thereof and requiring such plans, specifications and estimates and probable cost to be filed in the office of the Recorder of the City of Albany on said August 26th, 1914 and said resolution being endorsed "Resolution No. 28, adopted Aug. 26, 1914" and

Whereas the City Engineer of said City of Albany, pursuant to said Resolution No. 28 made plans, specifications and estimates as directed by said resolution for the construction of said sewer in the manner specified in said resolution No. 28 and filed said plan specifications and estimates in the Recorder's office in said city on the 26th day of August, 1914; and

Whereas the said city council on the 26th day of August, 1914, by Resolution No. 29 duly adopted by said council determined and resolved that it deems it expedient and that said council's purpose to construct said lateral sewer beginning at the west end of lateral sewer constructed through Block 16, across Dennis Street, through the center of Block 15, across Cleveland Street and 40 feet into Block 6, all in Hackleman's Fourth Addition to the City of Albany, Oregon, as provided by the charter of said city of Albany, and

Whereas the Recorder in pursuance of said order and direction of the council of said City of Albany did duly give notice of said proposed improvement in the manner provided by the charter of said city; and

Whereas the said council in said Resolution No. 29 ascertained and determined the total probable cost of making said improvement to be paid by the owners of the real property adjacent to said improvement as mentioned in said Resolution No. 29 to be the sum of

\$2,95.87 and the total probable cost of making said improvement \$17.02.

Therefore

The People of the City of Albany Do Declare As Follows:

Section 1. That one eight inch vitrified terra cotta lateral sewer shall be laid beginning at the west end of lateral sewer constructed through Block 16, across Davis Street, through the center of Block 15; across Second Street and west into Block 6, all in Hackmann's Towne Addition to the City of Albany, Oregon.

All in accordance with said Resolution No. 28 and the plans and specifications for said improvement filed by the City Engineer with the Recorder of said City of Albany, on the 16th day of August, 1911.

Section 2. That the probable cost of making said improvement in the manner heretofore determined by the council of said City of Albany in and by all Resolution No. 26 is here determined to be the sum of \$417.02 and the probable cost of said improvement to be paid by the property adjacent and especially and particularly benefited thereby is the sum of \$2,95.87.

Section 3. That the proportionate share of said probable cost of said improvement assessed upon each lot or part thereof adjacent to said improvement as aforesaid and as determined by said council in and by said Resolution No. 29 is such ascertained and determined to take account and place in immediate after the separate description of each of said lots or parts thereof, as follows:
