

## ORDINANCE No. 710.61K

Rawlings, Albany, Oregon

An ordinance to ascertain, determine and declare the cost of constructing a cement sidewalk on the 1<sup>st</sup> Street on the North side of and adjacent to the Southeast corner of Block 62 in the City of Albany, Oregon, and to assess and collect upon said sidewalk a sum upon said sidewalk and directing said sum to be entered in the account of City expenses.

Whereas on the 7<sup>th</sup> day of October, 1914, the Superintendent of Streets of the City of Albany reported his meeting to the council that sidewalk should be built on 1<sup>st</sup> Street on the North side of and adjacent to the Southeast corner of Block 62 in the City of Albany, Oregon; and

Whereas the council on said 7<sup>th</sup> day of October, 1914, duly passed Resolution No. 30, ordering said sidewalk constructed within twenty days from said October 7<sup>th</sup>, 1914, which resolution specified the materials, location, stone, the material to be used and that the construction should be in accordance with Ordinance No. 468; and

Whereas, within ten days after the said order to build said sidewalk on October 7<sup>th</sup>, 1914, the Superintendent of Streets did post a notice upon the Southeast quarter of Block 62 in the City of Albany, Oregon, adjacent to the sidewalk ordered to be built reading "Notice to Citizen! Sidewalk in letters 10 ft. east and one-half feet in length shall be built in good character, directed to the owner of said property G. W. Strong to build said sidewalk within ten days from said October 7<sup>th</sup>, 1914; and

Whereas the Superintendent of Streets did file with the Recorder an affidavit of the posting of such notice, stating the date when and the place where the same was posted; and

Whereas the Recorder filed within five days from said order of October 7, 1914, and by mail a notice to build said sidewalk to the owner of said property, G. W. Strong, directed to the post office address of Albany, Oregon, 21<sup>st</sup> Street, south, Oregon, and;

Whereas the owner of said Southeast quarter of Block 62, in the City of Albany, Oregon, to-wit: G. W. Strong, failed, neglected and refused to build said sidewalk within the time ordered by the council; and

Whereas the Superintendent of Streets has built said sidewalk and kept an accurate account of the cost of labor and material in building said sidewalk adjacent to said street above described and, according to records as now in possession of the cost of said sidewalk together with a description of the lot or part thereof, a parcel of land, according to the description upon which said sidewalk was, very briefly, as follows:

Whereas the council has inspected the said report of the Superintendent of Streets concerning the cost of said sidewalk and the same, which cost is the sum of \$177.77, and

Whereas the council has voted to enter the same in the account of the

Ordinance is hereby approved.

Therefore:

The People of the City of Albany do Ordain as Follows:

Section 1. That we cost of building the sidewalk on Ninth Street on the South side, and adjacent to the Southeast quarter of Block 62, in the City of Albany, Oregon, was and is the sum of \$76.77.

Section 2. That there be and there is hereby assessed upon the said Southeast quarter of Block 62 in the City of Albany, Oregon, for said sidewalk construction the sum of \$76.77 and that the same be and is hereby made a lien upon said premises until the sum is paid thereon and the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the said sum as a debt and lien together with the name of the owner of said Southeast quarter of Block 62 in the City of Albany, Oregon, G.W. Strong, in the Book of Lien of the City of Albany, as provided by the charter of said city, and that the Recorder shall forthwith give notice in writing as provided in Section 228 of the Charter of the City of Albany to the owner or reputed owner of said real property.
