

Be it ordinance of the City of Williams, Oregon, making and enacting the same as follows:

Section 1. That a sum of \$1,088.73 per cent is hereby levied and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and the Capital Improvement Company, for the improvement of Terry Street, running North from the South line of Twelfth Street and in favor of the owners of the various parcels of real estate abutting upon and adjacent to said portion of said Terry Street, according to the agreed upon plan and agreement.

The People of the City of Williams do Ordain as follows:

Section 1. That a sum of \$1,088.73 per cent is hereby levied and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and the Capital Improvement Company, for the improvement of Terry Street, running North from the South line of Twelfth Street and in favor of the owners of the various parcels of real estate abutting upon and adjacent to said portion of said Terry Street, according to the agreed upon plan and agreement.

Section 2. The Recorder of the City of Williams is hereby directed to enter in the docket of Public Works in the surplus column, credit a credit of \$1,088.73 per cent based upon the several amounts rendered acreeved and entered herein to defray the cost of the improvement of said Terry Street; said surplus being in favor of the following named persons, owners or reputed owners of such various parcels of real estate as are in excess as follows, to wit:
