

An Ordinance declaring a surplus on account of the construction of a lateral sewer by W. S. Meavis beginning at the manhole in West Street trench sewer, which is about midway between Santiam Road and Salem Road in the City of Albany, Oregon, and running westerly 350 feet, in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, here-to-re assessed and entered of record in the book of city taxes in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

The People of the City of Albany Do Ordain As Follows:

Section 1. That a surplus of 6.20 per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany Oregon and W. S. Meavis for the construction of lateral sewer beginning at the manhole in West Street trench sewer, which is about midway between Santiam Road and Salem Road in the City of Albany, Oregon and running thence westerly 350 feet, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement here-to-re assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Book of City Taxes in the surplus column thereof a credit of 6.20 per cent, based upon the several amounts, here-to-re assessed and entered thereon to defray the cost of the improvement of said lateral sewer; said surplus being in favor of the following named persons, owners or reputed owners of such various parcels of real estate and in sum is as follows, to-wit:
