

the subscriber, Mr. H. G. and L. Record, of the
City of Albany, to enter into a contract with Wm. H. Junkins, or his
successor and contractor, to maintain, repair, improve and care
for certain streets and public ways situated in and about the
City of Albany, between Franklin and Eighth Streets,
and running in a north-easterly direction across Block 1, across Pine Street, and
68 feet into Block 1, a city known as the Woodland Addition to the
City of Albany, Oregon, with vitrified terra cotta sewer pipe according
to the plans, specifications and notices filed in the office of the
Recorder of the City of Albany on the 8th day of April, 1894.

Whereas, on the 2nd day of April, 1894, it was ordered by the
Council of the City of Albany, Oregon, passed by the Council with the advice of the City Engineer, it was ordered
that the above described, street, sewer be constructed, said improvement
to be made in accordance with the charter and ordinances of the City
of Albany and the plans, specifications and rates noted by the City En-
gineer thereon or file with the Recorder of the City, Albany, and

Whereas, it was provided by ordinance that the Recorder
of the City of Albany give notice to the City making of said im-
provement in them and as provided in law and by said ordinance;
and

Whereas, after due notice and advertisement for bids
made and given above Recorder of the City of Albany according to said
ordinance, on the 1st day of May, 1894, H. G. and L. Record, or H. G. Junkins, or
his successor, did bid for and make a bid for improvement,
which bid was made in due form and in conformity with all the con-
ditions imposed by law, and with ordinance, and said bid
said H. G. and L. Record, and the same agreed to and is hereby made
and accepted by the City of Albany, Oregon, to construct the
above described improvement in the manner, especially and

Whereas, the City of Albany, Oregon, in want of
improved public ground for a park and school yard, and such yard was the only
one not recorded;

Now, therefore,

be it enacted by the City of Albany, Oregon, as follows:

(Section 1.) That the City of Albany, Oregon, with
Junkins for said improvement as aforesaid, same is hereby accepted
and the Mayor and Recorder of the City of Albany are hereby authorized
to enter into a contract in writing with the said H. G. Junkins,
and his successors for the making of said improvements as aforesaid
and to pay to him, or his assigns, the sum of one thousand dollars

in said office once advertisement and bid returns are mentioned. Said contract shall provide that the work so said never shall commence within ten days after the signing of said contract and be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed no or before the 1st day of July, 1915; and the City of Albany, Oregon, shall be deemed to suffer damages to the extent of \$2.50 per day, for each and every day the work is delayed beyond said specified time.

Said contract shall further provide that the said W. H. Beard and G. W. Jenkins shall, monthly, as due, make payment to all persons supplying to the said W. H. Beard and G. W. Jenkins labor or material for the prosecution of the hereinabove described work and that the said W. H. Beard and G. W. Jenkins p. all not permit any bill or claim to be filed or prosecuted against the City of Albany for or on account of any material or labor furnished for the said work.

The said W. H. Beard and G. W. Jenkins shall furnish a penal bond in the sum of \$175.00, with good and sufficient sureties to be approved by the Mayor of the City of Albany, to secure the faithful performance of the obligations contained in the said contract on the part of said W. H. Beard and G. W. Jenkins and a license is granted them or either for labor, work or material, notwithstanding any person arising out of said contracts.
