

Also Ordinance authorizing the Mayor and Recorder of the City of Albany, Oregon, to enter into a contract with the Asphalting Machinery Company, a corporation, for the improvement of Second Street from the East line of Lyon Street to the West line of Main Street.

The Work on the City of Albany Shall be as Follows:

Whereas by Ord. No. 796 of the City of Albany, Oregon it was ordered that the improvement of the City of Albany, Oregon, to-wit: Second Street from the East line of Lyon Street to the West line of Main Street be improved in the following manner to-wit:

- First: By making said street to the proper subgrade.
- Second: By paving the roadway, & said street, and width with full intersections with asphaltic concrete pavements or San asphaltic concrete foundations.
- Third: By laying and curbing asphaltic concrete.
- Fourth: By constructing concrete combination curb and walk.
- Fifth: By constructing catch basins.
- Sixth: By constructing inlets.
- Seventh: By laying vitrified sewer pipe.
- Eighth: By laying sub-drain tile.

And in pursuance to be made in accordance with the charter and ordinances of the City of Albany, and the amended plans, specifications and estimates of the Civil Engineer thereof filed with the Recorder of said City of Albany and

Whereas it was provided in said ordinance that the Recorder of the City of Albany give notice for bids for the making of said improvement in the manner provided for and by said ordinance, and

It was, after due notice and advertisement for bids made and given in accordance with the ordinance to-wit: as provided for in said ordinance, and the said ordinance, to-wit: on the 1st day of July, 1905, as hereinafter provided, presented to the Board of Public Works of the City of Albany, Oregon, a contract with asphaltic concrete pavements, which bid was made in due and lawful conformity with all the conditions imposed by law and the Council, by which said bid was granted Machinery Company proposed to furnish all material and implements and perform the labor necessary to make the same in accordance with asphaltic concrete

partments, at the following estimated prices, to-wit:

Excavation, per cubic yard,	\$ 0.75
Fill or embankments, per cubic yard,	\$ 0.30
Asphaltic Concrete Surfaces, including the surface finishing course and the joint lamination course, per square yard,	\$ 1.05
Six inch sewer pipe, per lineal foot,	\$ 0.55
Joints, standard, each	\$ 1.00
Various manhole readers, per lineal foot,	\$ 0.35
Manholes, each	\$ 3.00
Tapping lateral or main sewer, each	\$ 1.00
Digging trenches and laying 3-inch drain tile, complete, per lineal foot,	\$ 0.15
Concrete combination curb and wall, per lineal foot,	\$ 0.80
Four inch cast iron pipe, per lineal foot,	\$ 1.00

And Whereas, said Asphalt Machinery Company was the lowest bidder for said proposed work and said bid was the lowest and best bid therefor.

Section 1. That the bid of Asphalt Machinery Company for said improvement of said described portion of Second Street with Asphaltic Concrete pavement be and the same is hereby accepted and the Mayor and Recorder of said City are hereby authorized to enter into a contract in writing with said Asphalt Machinery Company, a corporation for the making of said improvement with asphaltic concrete pavement on the east side of the City of Albany, Oregon, upon the terms mentioned in said bid, which are as follows:

Said contract to provide further that the work of said improvement shall be commenced within ten days after the signing of said contract and shall be prosecuted with all due vigor that all the work embraced in said contract shall be entirely completed on or before the first day of September, 1915, and the City of Albany, Oregon, shall be deemed to have advanced to the contractor the sum of \$25,000 per day for each and every day the work is delayed beyond said specified time, and that the Asphalt Machinery Company be and shall be bound to the sum of Five Thousand Dollars, to be approved by the Mayor of the City of Albany, Oregon, having as surety some surety company authorized to do business in the State of Oregon, conditions being the faithful performance of the said contract on the part of Asphalt Machinery Company and further indemnification in the case of liability against and claims...

here for labor, work or materials on the part of any person, firm or corporation, arising out of said contract.
