

An Ordinance authorizing the Mayor and Recorder of the City of Albany, Oregon, to enter into a contract with M. T. McAllister for the improvement of Nine Street from the south line of Salina Road to the north line of Santiam Road.

The People of the City of Albany do ordain as follows:

Whereas by Ordinance No. 812 of the City of Albany, Oregon, it was ordered that the following street in the City of Albany, Oregon, to-wit: Nine Street from the south line of Salina Road to the north line of Santiam Road be improved in the following manner, to-wit:

First: By grading said street to the required grade and sub-grade.

Second: By graveling said street six inches deep and eight feet wide.

Said improvement is to made in accordance with the charter and ordinances of the City of Albany and the plans, specifications and estimates of the City Engineer then on file with the Recorder of the City of Albany; and

Whereas, it was provided in said ordinance that the Recorder of the City of Albany give notice for bids for the making of said improvement in the manner provided by law and by said ordinance; and

Whereas, after due notice and advertisement for bid made and given by the Recorder of the City of Albany according to law and the ordinance last aforesaid, to-wit, on the 23rd day of June, 1915, M. T. McAllister presented to the Council of the City of Albany, his bid for making said improvement, which bid was on sole in due form and in conformity with all the conditions imposed by law and the Council, by which said bid, said M. T. McAllister proposed to furnish all material and implements and perform the labor necessary to make the above described improvement in the manner specified in the plans and specifications therefor for the sum of \$111.00 and

Whereas, said M. T. McAllister was the lowest and best bidder for said proposed work and said bid was the lowest and best bid therefor.

Section 1. That the bid of M. T. McAllister for said improvement of said described portion of Nine Street to-wit the paving in heavy asphalt and the shoveling, wheelbarrowing and labor in connection therewith be accepted and the amount of \$111.00

McAllister for the making of said improvement in the manner specified in the plans and specifications thereto upon the terms mentioned in said bid hereinabove mentioned.

Said contract shall provide that the work of said improvement shall commence within ten days after the signing of said contract and shall be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before the first day of August, 1915, and the City of Albany, Oregon, shall be deemed to suffer damages to the extent of \$2.50 per day for each and every day the work is delayed beyond said specified time, until that the said W. T. McAllister shall furnish a bond in the sum of One Hundred Dollars, to be approved by the Mayor of the City of Albany, Oregon, conditioned for the faithful performance of the said contract on the part of said W. T. McAllister and further indemnifying the City of Albany against any claims or lien for labor, work or materials on the part of any person, firm or corporation, arising out of said contract.
