

On the 1st day of January, 1888, the People of the City of Albany, Oregon, do hereby declare, as a sufficient cause for the construction of a lateral sewer by C. H. Swartley, beginning at the manholes in Pearry Street and trunk sewer, at the intersection of said Pearry Street with the 7th Street extended in the City of Albany, Oregon, and running thence westerly across Pearry Street and between lots 6 and 7 of Block 11 of Bryant's Addition to the City of Albany, Oregon, a distance of 138 feet, to the northwesterly corner of Lot 7 of said Bryant's Addition, thence northerly along the center line of said Block 11 a distance of 266 feet; also beginning at said w.c. line at corner of lot 7, running easterly along the center line of said Block 11, a distance of 138 feet to a point near the north side of Fairlane Road, where beginning at a point where the above named lateral sewer intersects the corner of Lots 10, 1, 31 and 32 in said Block 11 and running thence westerly between lots 31 and 32, across Fairlane Street to and along the line between lots 48 and 49 of Block 12 of said Bryant's Addition, a distance of 29 feet; thence northerly along the boundary line between Bryant's Addition and Bryant's Second Addition a distance of 330 feet to a point near the northerly corner line of said Bryant's Addition and Bryant's Second Addition; also beginning at the northwesterly corner of said Lot 49 of said Block 12 and running northerly along the boundary line between said Bryant's Addition and said Bryant's Second Addition to a point near the northern boundary line of Fairlane Road, all in the City of Albany, Oregon, and being a total distance of 984 feet, and directing the Recorder of the City of Albany to enter to the credit of the owner or owners of the various parcels of real estate adjacent to said improvement, herefore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such expense.

The People of the City of Albany do declare as follows:

Section 1. That a surplus of 8.65% percent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and C. H. Swartley for the construction of a lateral sewer beginning at the manholes in Pearry Street and trunk sewer at the intersection of said Pearry Street with the 7th Street extended in Bryant's Addition to the City of Albany, Oregon, and running thence westerly across Pearry Street and between lots 6 and 7 of Block 11 of Bryant's Addition to the City of Albany, Oregon, a distance of 138 feet to the northwesterly corner of Lot 7 of said Bryant's Addition, thence northerly along the center line of said Block 11 a distance of 266 feet; also beginning at said northwesterly corner of Lot 7 of said Bryant's Addition, thence northerly along the center line of said Block 12 a distance of 29 feet; thence eastward

southwesterly along the center line of said Block 11 a distance of 630 feet to a point near the south side of Santiam Road; also, beginning at a point where the above named lateral sewer intersects the corner of Lots 11, 1, 3, and 6, in said Block 11, running thence westerly between lots 3 and 6, across Sherman Street and along the west return of lots 18 and 19 of Block 12 of said Bryant's Addition, a distance of 220 feet to the northwesterly corner of said Block 12; thence northerly along the boundary line between Bryant's Addition and Bryant's Second Addition a distance of 330 feet to a point near the northern boundary line of said Bryant's Addition and Bryant's Second Addition; also beginning at the northwesterly corner of said lot 19 of said Block 12 and running northerly along the boundary line between said Bryant's Addition and said Bryant's Second Addition to a point near the northerly boundary line of Santiam Road, all in the City of Albany, Oregon, and being a total distance of 1,284 feet, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of Citizens in the surplus column thereof a credit of \$658 per cent, based upon the several amounts heretofore assessed and entered herein to defray the cost of the construction of said lateral sewer; said surplus being in favor of the following named persons, owners or reputed owners of such parcels of real estate and in sums as follows, to-wit:
