

One O. D. L. once declaring a surplus on account of the improvement of Main Street by Aschalt Machinery Company from the south line of Water Street to the south line of Fourth Street in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Record of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such a surplus.

The People of the City of Albany do ordain as follows:

Section 1. That a surplus of 12.146 per cent is hereby ascertained and declared to exist in a 1/16 completion of the contract entered into between the City of Albany, Oregon, and Aschalt Machinery Company, or their assigns, of Main Street from the south line of Water Street to the south line of Fourth Street in the City of Albany, Oregon, and due to the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Record of City Liens in the surplus column thereof a credit of 12.146 per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of improving said street, said surplus being in favor of the following named owners or reputed owners of several parcels of real estate and in sums as follows, to wit:
