AN ORDINAN TO DESTABLING A SURPLUS ON ACCOUNT OF THE CONSTRUCTION OF A LATTICAL STATE OF W.S. TRAVER STOLKING AT THE LAMP HOLY AT THE PASY-TRN THO OF THE LATTHAL STWEE HOW IN PLACE IN THE SAUTIAN ROAD AND EXTENDING IN A SOUTH-TAST THLY DIRTCTION ALONG SAID SAUTIAM ROAD A DISTANCE OF 320 FEET, IN HACKLEMAN'S HTIKS IST ADDITION TO THE SITY OF ALLASY, ON TOOK, AND DI-RECTING THE RECONDER OF THE CITY OF ALBRINY TO FLACT TO THE CARDIT OF THE BENERAL OWNERS OF THE VARIOUS PARCELS OF REAL TSUATE ADJACENT TO SAID IMPROVEDENT, HEATTOFORE ASSESSED AND THICK-FD OF RECORD IN THE DOCKET OF CITY LITTE IN THE CITY OF ALBANY, OATSON, FOR MAKING SUCH IM-PROVIDENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THY PEUPLE OF THE CITY OF ALBANY DO CADAIN AS FOLLOWS:

Section I. That a surplus of 5.58 per cent is here by ascertained and declared to exist upon the completion of the contract entered into by and between the city of Albany, Oregon, and W.S. Weaver for the construction of a lateral sewer beginning at the lamp hole at the eastern end of the lateral sewer now in place in the Santiam head and extending in a South-easterly direction should said Santiam head and extending in a South-easterly direction should said Santiam head a distance of 320 feet, in Hackleman's Heirs Ist Addition to the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City liens in the surplus column thereof a credit of 5.58 per cent, based upon the several adounts heretofore assessed and entered therein to defray the cost of the improvement of said interal sewer; said surplus being in favor of the following named persons, owners or reguted owners of such paraels of real estate and in sums as follows, to-wit;
