ORDINANCE NO. 383

AN ORDINANCE DECLARING A SUAPLUS ON ACCOUNT OF THE CONSTRUCTION OF A LATERAL SEWER BY M. T. MCALLISTER AND P.H. WALTON BEGINNING AT THE MANHOLE IN THE OAK STREET TRUNK SEWER BETWEEN FRONT AND WATER STREETS AND RUBBING WEST-ERLY ACROSS SHERMAN STREET, THROUGH THE CENTER OF BLOCK 2, TO WITHIN FORTY FRET OF THE BAST LINE OF MAIN STREET I'V HACKLEMAN'S THIRD ADDITION TO THE CITY OF ALBANY CREGON, AND DIRECTING THE ASCORDER OF THE CITY OF ALBANY TO PLACE TO THE CREDIT OF THE SEWERAL OWNERS OF THE VARIOUS PARCEDS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIETS IN THE CITY OF ALBANY, ORNGON, FOR MAKING SUCH IMPROVEMENT, THEIR PROPERTIONATE SHARE OF SUCH SURPLUS.

THE PROFLE OF THE CITY OF ALBANY DO ORDAIN AS FOLIOWS:

Section I. That a surplus of 2 I/2 per cent is hereby ascrtained and declared to exist upon the completion of the contract entered into by and between theCety of Albany, Oregon, and M. T. McAllister and P. H. Walton for the construction of a lateral sewer beginning at the manhole in the Osk Street Trunk Sewer between Front and Water Streets and running Westerly assess Oak Street, through the center of Block 9, across Sherman Street through the center of Block 2, to within forty feet of the Mast line of Main Street in Hakleman's Third Addition to the City of Albany, Oregon, and in favor of the several owners of the various parels of real estate adjacent to said improvement here tofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit of 2 I/2 per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of making the improvement of eaid lateral sewer; eaid surplus being in favor of the following named persons, owners or reputed owners of such parcels of real estate and in sums as follows, to-wit:
