ORDINANCE No. 503

AN ORDINANCE REGULATING THE DRIVING AND MOVING OF STOCK THROUGH THE PUBLIC STREETS AND ALLEYS OF THE CITY OF ALBANY, OREGON, PROVIDING FOR THE MANNER IN WHICH THE SAME MAY BE MOVED AND PUNISHMENT FOR VIOLATION THEREOF, AND TO REPEAL ORDINANCE NUMBER 432 ENTITLED "AN ORDINANCE REGULATING THE DRIVING AND MOVING OF STOCK THROUGH THE PUBLIC STREETS AND ALLEYS OF THE CITY OF ALBANY, OREGON, PROVIDING THE MANNER IN WHICH THE SAME MAY BE MOVED AND PUNISHMENT FOR VIOLATION THEREOF", PASSED BY THE COUNCIL AUGUST 28TH, 1907, AND APPROVED BY THE MAYOR AUGUST 28TH, 1907, AND ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person or persons to drive any cow or cows, horse or horses, cattle, sheep or other animals through any public street or alley within the City of Albany, Oregon, except as herein-after provided, without having control of said animal or animals with reins or ropes or other fastenings and in the hands of some person sufficiently able to manage and control said animal or animals; provided that nothing in this ordinance contained shall be deemed to prohibit the driving or moving of such animals upon or through Calipoola Street in said City, and North and West of the following described line, to-wit: Beginning at the point where the East line of Calipoola Street intersects the South line of First Street and running thence Easterly along the South line of First to the East line of Washington Street; thence Northerly along the East line of Washington Street to the South line of Water Street, ^{thence easterly along the line of Water Street} to the West line of Geary Street.

Section 2. It shall be unlawful for any person or persons to permit or allow any stock or animals to trespass or go upon the premises of any person unless the owner of such stock or animals shall have first obtained permission of the owner or tenants of such premises.

Section 3. Any person or persons violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof before the Recorder's Court shall be fined not less than \$5.00 nor more than \$50.00 or shall be imprisoned in the City Jail not less than two days or more than 25 days, or by both such fine and imprisonment, at the discretion of the Court.

Section 4. That Ordinance No. 432 entitled "An Ordinance regulating the driving and moving of stock through the public streets and alleys of the City of Albany, Oregon, providing the manner in which the same may be and punishment for violation thereof", passed by the Council August 27th, 1907, and approved August 28th, 1907, and all other ordinances or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.
