ORDINANCE NO. 313

AN ORDIFARCE ARTHORIZING AND PROVIDING FOR A SPECIAL ELECTION WITHIN THE CLTY OF ALBANY, OAFGON, TO YOTE ON AGENDMENTS TO THE CHARTER OF SAID CITY PROTOCED BY THE COUNCIL OF THE CITY OF ALBANY AND SUBSTITUTE TO THE PROPER, PROVIDING NOW THE EXPENSE OF SUCH PROTION SHALL BE DAID AND DECLARING AN EMERCENCY.

WHEREAS by the special election of the State of Ore on held June 4th, 1917, Article II of the Constitution of said State was amended by the electors by adding another section after Section after Section 14 thereof, said section now being designated as Section 14-a, and providing in substance, among other things, that incorporated cities and towns shall hold their nominating and regular elections for their several elective officers at the same time that the primary and general biennial elections for State and County officers are held, and that cities and towns shall smeet such supplementary legislation as may be necessary to carry the provisions of this amendment into effect, and

WHERMAS, the Council of the City of Albany, by Resolution No., 16 adopted on the 24th day of October 1917, submitted to the people for their approval or rejection certain proposed charter amendments providing for the length of the terms of the respective elective officers of said City and the repeal of certain sections of said charter now rendered nugatory by the aforesaid constitutional amendment;

THREFORE

THE PROPER OF THE CITY OF ALBANY DO ORDAIN AT FOLLOWS:

Section 1. A special election shall be held in the several wards of the City of Albany on Monday, December 3rd, 1917, for the purpose of voting upon certain proposed charter amondments, submitted to the people by the Council of said City for their approval or rejection, providing for the length of the terms of the respective elective officers and the repeal of certain sections of the charter now rendered nugitory by the Constitution of the State of Oregon. At such special election the polls shall be opened at the hour of 9 o'clock A.M. and shall be closed at the hour of 7 o'clock F.M. without interruption, and the votes shall be cast, counted, canvassed and returned in the same manner as provided by law for all lawsor measures submitted to the people at regular elections.

Section 9. All bills contracted to meet the expenses incident to the carrying into effect of this ordinance shall be sudited and paid out of the general fund as other claims against the city are paid; and the Recorder is hereby authorized and directed to give the proper nation of olderion as provided by the Charter of said Sity.

Section 3. It is hereby declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety, and therefore an emergency is declared to exist, and this ordinance shall take effect immediately from and after its approval by the Payor.
