## ORDINANCE NO. 994.

AN ORDINANCE DECLARING A SUMPLUS ON ACCOUNTOF THE IMPROVEMENT BY BEQUAL DAVIS OF PINE STREET FROM THE NORTH LINE OF SALEM HOAD TO THE WILLAMETTE RIVER IN THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALBANY TO PLACE TO THE CERDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS IN THE CITY OF ALBANY, OREGON FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.
