AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT BY BOOM & DAVIS OF PINE STREET FROM THE NORTH LINE OF RIGHTH STREET NORTH TO THE SOUTH LINE OF SANTIA AN STREET, IN THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALbany, Oregon and directing the Recorder of the City of Albany to place to the credit of the several orners of the various parcels of real estate adjacent to sid improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon for making such improvement, their proportionate share of such surplus.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1.
