

ORDINANCE NO. 1016.

AN ORDINANCE, DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT BY L.O. HERROLD ON THIRD STREET FROM THE WEST CURB LINE OF RAILROAD STREET TO THE WEST LINE OF MAIN STREET IN THE CITY OF ALBANY, OREGON, AND DIRECTING THE RECORDER OF THE CITY OF ALBANY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS IN THE CITY OF ALBANY, OREGON, FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. That a surplus of \$ 5442.42 is hereby ascertained, determined and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and L.O. Herrold for the improvement of Third Street from the West curb line of Railroad Street to the West line of Main Street in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.


