

ORDINANCE NO. 1020, _____

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT BY L.O. HERROLD ON THE ALLEY BETWEEN THIRD STREET AND FOURTH STREET THROUGH BLOCK NO. 19 IN THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALBANY, TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE BOOKS OF CITY LIENS IN THE CITY OF ALBANY, OREGON FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. That a surplus of \$ 281.99 is hereby ascertained, determined and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and L.O. Herrold for the improvement of the Alley between Third Street and Fourth Street through Block No. 19 in the City of Albany, Oregon and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section II. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit in favor of the following named persons, owners, or reputed owners of such parcels of real estate and in the sums as follows, to-wit:
