

ORDINANCE NO. 1576

A BILL FOR AN ORDINANCE GRANTING WNO C.A. BRUCKNER THE RIGHT AND PRIVILEGE TO OPERATE UPON THE STREETS OF THE CITY OF ALBANY, OR UPON THE FORD AUTOMOBILES DESCRIBED HEREIN AND TO CARRY ON THE BUSINESS OF CARRYING PASSENGERS BETWEEN POINTS WITHIN THE CITY OF ALBANY AND FROM POINTS WITHIN THE CITY OF ALBANY TO POINTS WITHOUT THE CITY OF ALBANY AND FROM POINTS WITHOUT THE CITY OF ALBANY TO POINTS WITHIN THE CITY OF ALBANY, OREGON.

THE BOARD OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. That it is hereby granted unto C.A. Bruckner the right and privilege to operate along, in, upon and over the streets and alleys and other public places in the City of Albany, the following described motor vehicle:

One 4-passenger sedan automobile with pneumatic tires; license No. 43348 for the year 1922;

and to conduct a business with the said four-passenger Ford Sedan automobile from and to various points within the City of Albany and from points within the City of Albany, and from points without and within the City of Albany, and no other to be used in the conduction of said business under this franchise, unless the Council shall upon application of said grantee, permit of a substitution or addition to said equipment.

Section II. That the said grantee shall maintain a telephone stand within the City of Albany, and maintain and keep a telephone number for the convenience of persons and the public desiring to employ said grantee in said passenger carrying business.

Section III. That the said grantee shall in consideration of the privileges herein granted pay to the City of Albany the sum of \$ 17.00 which said sum may be divided into three equal parts and paid in advance.

Section IV. That the rates set forth and mentioned by said grantee in his application of file in the office of the City Recorder be and the same are hereby referred to and made a part of this ordinance and said grantee shall not change said rates without first giving the City of Albany three days written notice of his intention to do so by letter or public meeting.

Section V. That the privileges herein granted shall inure to and may be exercised by the said grantee for a period commencing on March 1st, 1922 and ending on January 1st, 1923, unless the same shall be sooner revoked for the cause herein contained.


