

ORDINANCE NO. 1035

A BILL FOR AN ORDINANCE Granting unto the "Star Transfer Company" a copartnership, the right and privilege to operate upon the streets of the City of Albany the trucks described herein, and to carry on the business of transporting goods, wares and merchandise and other material within the City of Albany, Oregon.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. That there is hereby granted unto the "Star Transfer Company" a copartnership, the right and privilege to operate along and upon the streets, alleys and other public thoroughfares in the City of Albany, Oregon, the following described motor trucks, to-wit:

One 1½ Ton Maxwell Truck; Oregon
license, 1922, No. 70846.
One 1 Ton Chevrolet Truck; Oregon
license, 1922, No. 70846.

and to conduct a general transfer business within the City of Albany with said trucks, and no other can be used in the conduct of said business under this franchise, unless the Council shall upon application by the said grantee permit substitution or addition to said equipment.

Section II. That the said grantee shall maintain a telephone and place of business within the City of Albany, and notice of the location of said business shall be given all persons desiring or employing said grantee.

Section III. That the said grantee shall in consideration of the privilege herein granted, pay to the City of Albany the sum of \$_____, which said sum may be divided into three equal parts and be paid in advance.

Section IV. That if the said grantee shall fail or refuse to make any such payment of the amount herein reserved to the City of Albany when the same becomes due and payable, or shall be convicted of violation of the laws of the State of Oregon, or the ordinances of the City of Albany relating to motor vehicles, such failure or conviction shall be deemed sufficient cause for the revocation of this franchise and the right of revocation for such causes is hereby reserved by the City of Albany.

Section V. That the privilege herein granted shall inure to and may be exercised by the said grantee for the period commencing on the _____ day of March, 1922 and ending on the 1st. day of January, 1923, unless the same shall be revoked for the causes specified in Section IV, of this ordinance.
