A BILL FOR AN ORDINANCE Authorizing and directing the Treasurer of the City of Albany, Oregon, to reselve from E. L. Hackleman the payment of a certain portion of an assessment heretofore made by the City of Albany upon certain described property heretofore owned by T. P. Hackleman and E. L. Hackleman as tenants by the entirety, and further providing that upon the filing in the office of the City Recorder of the City of Albany of a duplicate receipt therefor that the said City Recorder cause said property to be released from the effect of said assessment.

WHEREAS, Heretofore the City of Albany under and by virtue of the charter provisions of the charter of said City of Albany and in pursuance of the proceedings had thereunder the said City of Albany caused to be imposed upon the following described premises, to-wit:

Hackleman to the City Treasurer of the City of Albany in satisfaction of the lien upon the premises described in Section I hereof, to enter upon the bond lien docket in Volume III at Page 79 thereof upon the proper line and in the proper column thereof, proper showing that the assessment lien upon said property has been satisfied in full.
