

ORDINANCE NO. 1064

A BILL FOR AN ORDINANCE Authorizing and directing the Recorder of the City of Albany to cancel certain assessment liens heretofore made by the Common Council of the City of Albany for the purpose of paying the cost of the construction of a sewer through Block No. 30, in the City of Albany, Oregon, and provided further that any property owners owing property in said Block No. 30 in the City of Albany, Oregon who hereafter desires to use said sewer, shall pay the proportionate cost thereof.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the City Recorder of the City of Albany, Oregon, be and he is hereby authorized and directed to cancel certain assessment liens heretofore imposed by Ordinance No. 964, and Ordinance No. 969, which said assessment liens are liens for the cost of construction of the sewer described in said Ordinance numbered as above, and which said property upon which said assessment liens are to be cancelled is described as follows:

J. H. Bikman,

Beginning at the N.W. corner of Lot 1, in Block 30, City of Albany and running thence East 28 feet; thence Southerly 51½ feet; thence Westerly 28 feet; thence Northerly to beginning, lines to run parallel with boundary lines of said Block.

Geo. A. and Lillian Mason,

Beginning at a point 28 feet East of the N.W. corner of Block No. 30, City of Albany, and running thence Easterly 56½ feet; thence Southerly 51½ feet; thence Westerly 56½ feet, thence Northerly to beginning. All lines to run parallel with the boundary lines of said Block.

W. H. Ridgeway,

The East 50 feet of Lot 2 in Block 30 City of Albany; also beginning 50 feet West and 51½ feet South of the N.W. corner of Lot 3 in Block 30 City of Albany and running thence South 10 feet; thence West 2½ feet, thence North 10 feet, thence to beginning.

Ella B. Francis,

The North half of Lots 5 and 6 in Block No. 30, City of Albany, Oregon.

G. R. Kennell,

Beginning at the Southeast corner of Block 30, City of Albany, and running thence Northerly to the South line of the North half (South half of) of said Block; thence Westerly 72 feet; thence Southerly to the South line of said Block; thence Easterly to beginning. Lines to run parallel with boundary lines of said Block.

Lydia Wyatt,

The East 62½ feet of the South half of Lot 6, Block 30, City of Albany.

Georgiana Forster,

The South half of Lots 7 and 8 of Block 30, City of Albany.

I. M. Sears,

The North of Lots 7 and 8 in Block 30, City of Albany.

ORDINANCE No. 1064

Section 2. That the owners of the foregoing described property, or their successors in interest who may hereafter desire to connect up for drainage purposes their property or any part thereof with the sewer described in Ordinance No. 964, of the City of Albany, which make application to the Common Council of the City of Albany, and upon payment of the proportionate share of the cost of the construction of said sewer to the Recorder of the City of Albany, Oregon, they may proceed to make said connection.

Section 3. The proportionate share of the cost of any person desiring to connect up with said sewer shall be determined and fixed by the Common Council of the City of Albany, and the finding of the Council thereon shall be final and conclusive.
