A SILL FOR AN ORDINANCE Authorizing and appropriating the sum of Four Hundred and Fifty Dollars (\$450.00) for the purpose of aiding and making a preliminary survey and matters in connection therewith to obtain for the City of Albany a pure water supply and declaring an emergency.

WHEREAS, The following named cities, to-wit: Eugene, Springfield, Corvallis, Albany, Junction City, Salem, Jefferson, Brownsville and Lebanon, all being situated in the Willametta Valley, State of Cregon, have formed a preliminary organization for the purpose of obtaining pure water supply for said cities and the inhabitants thereof, and

WHEREAS, The proposed source of seid water supply is Clear Lake, which is situated Southeast of the City of Albany, Linn County, Oregon, near the summit of the Cascades Mountains, and

WHEREAS, In order to determine if said source of water supply is expedient, feasible and practicable, it is necessary that a preliminary survey and estimates of the cost of building a pipe line be made, and

whereas, Upon investigation and estimates that have been made it has been determined that a preliminary survey and estimates can be had for the sum of Six Thousand Dollars (\$8000.00) and

WHEREAS, The cost of said survey should be apportioned between the various municipalities in accordance with the number of inhabitants of each municipality, and

whereas, It is essential for the public health, peace and welfare of the citizens of the City of Albany, Linn County, Oregon, that a pure water supply be had.

THEREFORE THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there is hereby appropriated out of the General Fund of the City of Albany, Linn County, Oregon, the sum of Four Kundred and Fifty Dollars (\$450.00) to assist in paying the cost of making a preliminary survey and estimates of the cost of construction of a pipe line from Clear Lake through the Cities of Rugene, Springfiled, Corvellis, Albany, Junction City, Salem, Jefferson, Brownsville and Lebanon, all being situated in the Willamette Valley, State of Oregon.

Section II. That it is distinctly understood that the passage of this Ordinance and this appropriation of money herein provided for does not bind the city of Albany its officers, or agents, in may ranner, nor in excess of the amount hereby appropriated.

Section III. Whereas, It is necessary for the public, peace, health and welfare of the People of the City of Albany that the foregoing ordinance be immediately effective an emergency be and the same is hereby

declared to exter and this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.
