## ORDINANCE NO. 1143

A BILL FOR AN ORDINANCE Authorizing the Payor and Recorder of the City of Albany, Oregon, to enter into a contract with Guy F. Pyle for the improvement of Elm Street from the South line of Fifth Street to the North line of Ninth Street in the City of Albany, Oregon, and declaring an emergency.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLIC'S:

WHEREAS, By Ordinance No. 1132 of the City of Albany, Oregon, it was ordered that the following street in the City of Albany, Cregon, to-wit: Elm Street from the South line of Fifth Street to the North line of Ninth Street. be improved in the following marner, to-wit:

- By grading said street to the proper subgrade.
  By paving said street full width with Portland cement concrete pevent, or by peving said street full with with 2 inch
  Warrenite bitulithic weering surface pavenent on a 3 inch
  black base, or by peving said street full width with a 2 inch
  Warrenite bitulithic weering surface pavenent on e 4 inch compressed crushed rock base, or by paving said street full width with 2 inch Warrenite bitulithic weering surface pavement on a 4 inch ocapressed grave or gravel base.
- By laying reving headers. By laying 6 inch vitrified sewer pipe. 3.
- By constructinginlets
- By tapping sewers.

Said improvement to be made in accordance with the charter and ordinances of the City of Albany and the plans, specifications and estimates of Engineer Charles H. Leonerd, then on file with the Recorder of the city of Albany; and

WHEREAS. It was provided in seid ordinance that the Recorder of the wity of Albany give notice for bids for the making seld improvement in the manner provided by law and by said ordinance; and

WHEREAS, After due notice and advertisement for bids made and given by the Recorder of the City of Albany according to law and the ordinance last aforesaid, to-wit: on the 9th. day of July, 1924, Guy F. Pyle presented to the Council of the City of Albany, Cregon, a bid for making said improvement with 2 inch Farrenite bitulithic wearing surface pavement on a 3 inch black hase which bid was made in due form and in conformity with all the conditions imposed by law and the Council, by which said bid Guy F. Pyle proposed to furnish all material and implements and perform the labor necessary to make the above described improvement with 2 inch Marrenite bitulithic wearing surface pavement on a 3 inch black base for the following named prices to-wit:

440.3 oubic yards of excevation \$1.00 per co. yd. \$440.30
5331.5 sq. yds, of pavement 2 inch Werrenite bitulithic
wesring surface pavement on a 7 inch black base
at \$2.30 per sq. yd. \$12688.97
210 lineal feet of paving headers at 40 cts. per ft. \$84.00
368 lineal feet of 6 inch vitrified sever pipe

at 80 cts. per lineal foot
4 Inlets at \$30.00 each
3 sever tapping at \$10,60 each \$294.40 \$30.00

AND WHEREAS, said Guy F. Pyle was the lowest responsible bidder for said proposed work and said bid was the lowest and best bid therefor, and

WHERFAS, The Common Council of the City of Albany, Linn County, Oregon did in and by Resolution No. 29 heretofore duly and regularly adopted has

and selected as the type of deprovement to be made on seld street the following described: B inch Werrenite bitulithic wearing surface pavement on a 3 inch black base.

Section 1. That the bid of Guy F. Pyle for said improvement of said described portion of Elm Street with 2 inch Warrenite bitulithic wearing surface pavement on a 3 inch black base be and the same is hereby accepted and the Mayor and Recorder of said City are hereby authorized to enter into a contract in writing with the said Guy F. Pyle for the making of said improvement with 2 inch Marrenite bitulithic wearing surface pavement on 3 inch black base on behalf of the city of Albany, Oregon, upon the terms in said bid hereinabove mentioned.

Section 2. Said contract to provide further that the work of said improvement shall commence within ten days after the signing of said contract and shall be prosecuted with such vigor that all the work embraced in said contract shall be entirelycompleted on or before the 1st. day of October, 1924 and the City of Albeny, Oregon shall be deemed to suffer damages to the extent of Ten Dollars (\$10) per day for each and every day the work is delayed beyond said specified time, and that Guy Pyle furnish a bond in a sum equal to Fifty per cent (50%) of the proposal of contractor, to be approved by the Mayor of the City of Albeny, Oregon, having as surety some surety company authorzed to do business in the State of Oregon, conditioned for the faithful performance of said contract on the part of Guy F. Fyle and further indemnifying the City of Albany against any claim or lien for labor, work or material on the part of any person, firm, or corporation, arising out of said contract.

Section 3. WHEREAS, It is necessary for the public peace, health and safety of the people of the City of Albany that the foregoing improvement be immediately constructed and therefore an emergency exists and one is hereby declared to exist and this ordinance shall go into full force and effect immediately upon its passage by the Council and approval by the Mayor.
