

## ORDINANCE No. 1160

A BILL FOR AN ORDINANCE authorizing and directing the Recorder of the City of Albany to cancel certain street improvement assessment liens upon payment to the City Treasurer of the City of Albany of the sum of One Hundred Sixteen (\$116.00) Dollars and filing in the office of the City Recorder of the City of Albany, Oregon, a duplicate receipt therefor.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

That, WHEREAS, the City of Albany has heretofore levied an assessment upon lots numbered Six (6) and Seven (7) in Block numbered Three (3) in Wright's Addition to the City of Albany, Linn County, State of Oregon, for certain improvements, and

WHEREAS, the owner of the South Fifty (50) feet of lots numbered Six (6) and Seven (7) in block numbered Three (3) in said Addition desires to satisfy the pro rata assessment against said portions of said lots; and

WHEREAS, said assessment heretofore levied by the City of Albany against said lots in said Block No. Three (3) in Wright's Addition to the City of Albany, Linn County, Oregon, has been duly entered in the bond lien docket of the City of Albany, in volume 3 at page 107 thereof; and

WHEREAS, the proportion of said assessment against the south Fifty (50) feet of lots numbered Six (6) and Seven (7) in Block numbered Three (3) in Wright's Addition to the City of Albany, is the sum of One Hundred Sixteen (\$116.00) Dollars, which said assessment was levied against said property in the name of J.M.Hodge.

Section 1. The City Recorder of the City of Albany be and he is hereby authorized and directed, upon the payment of the sum of One Hundred Sixteen (\$116.00) Dollars to the City Treasurer of the City of Albany, Oregon, and the filing of a duplicate receipt therefor with said City Recorder, which said payment shall be made as the amount of the street assessment due the South Fifty (50) feet of lots numbered Six (6) and Seven (7) in block numbered Three (3) in Wright's Addition to the City of Albany, Linn County, Oregon; to cancel and mark as satisfied the lien now subsisting in favor of the City of Albany on the South Fifty (50) feet of lots Six (6) and Seven (7) in block numbered Three (3) in Wright's Addition to the City of Albany, Oregon.


