SECTION NOT 1143

AN ORDINANCE to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oregon, has determined to make in Resolution No. 9 adopted by said Council on the 26th day of March, 1925, on Seventh Street from the east curb line of Calapooia Street to the east line of Yukon Street in said City; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said Seventh Street that is assessed upon each lot, or part thereof, adjacent to said portion of Seventh Street to be so improved; to authorize and direct the Recorder of said Gity to enter a statement of said assessment in the Docket of the City Liens as provided by the Charter of said City.

WHERRAS, on the 26th day of March, 1925, the Council of the City of Albany, Oregon, duly adopted a resolution requiring Charles H. Leonard, Engineer, to prepare and file in the office of the Recorder of said City on the 26th day of March, 1925, amended plans, specifications and estimates of the probable cost of making the improvement of Seventh Street in said City from the East curb line of Calapooia Street to the east line of Yukon Street with a suitable hard surface pavement to be selected and approved by the Council; and

WHEREAS, the said engineer, pursuant to said Resolution, made amended plans, specifications and estimates as directed thereby for the improvement of said Seventh Street, and filed the same in the office of the Recorder of said City on the 26th day fo March, 1925, and

WHENEAS, the Council of eaid City, on the 26th day 6f March, 1925, by Resolution No. 9, duly adopted by said Council, determined and resolved that it deemed it expedient and that the Council proposed to improve Seventh Street from the east curb line of Calapooia Street to the east line of Yukon Street in the City of Albany, Oregon, in the manner provided in said Resolution No.

WHRHEAS, in and by said Resolution No. 9 adopted as aforesaid by the Council, the Recorder of said City was duly ordered and directed to give notice of said proposed improvement of said Seventh Street from the east curb line of Calapoois Street to the east line of Yukon Street as provided by the charter and ordinances of said City, and

WHEREAS, the Recorder in pursuance of said order and direction of the Council of said City of Albany, did duly give notice of said proposed improvement of said Seventh Street in the manner provided by said resolution and the charter and ordinances of said City, and

WHENFAS, the said Council in and by said Resolution No. 3 ascertained and determined the total probable cost of making said improvement of said Seventh Street to be paid by the owners of the real property adjacent to said portion of said Seventh Street to be improved as specified in said Resolution No. 9 to be the sum of \$24,143.79, and

WHEREAS, by Ordinance No. 1178 after due notice for the time and in the manner provided by law, the bid of Guy F. Pyle for the making of said improvement of said portion of Seventh Street was accepted and the Hayor and Recorder of the City of Albany were thereby suthorized to enter into a contract with Guy F. Pyle for the making of said improvement in accordance with said bid with Warrenite Bitulithic pavement and in other respects in accordance with said Resolution No. 9.

THEREFORE

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Seventh Street in the City of Albany, Oregon, from the east curb line of Calapooia Street to the east line of Yukon Street shall be improved as follows:

1st. By grading said street to the proper sub-grade.
2nd. By paving the roadway of said Street full width with full intersections (except as noted in the plans and specifications) with Warrenite Bitulithic payement.

3rd. By laying and constructing pavement headers.

Ath. By constructing concrete curbs wherever necessary.

5th. By constructing catch basins and inlets.

6th. By laying vitrified sewer pipes.

7th. By tapping the main sewer.

All in accordance with said Resolution No. 9 and the plans and specifications for said improvement filed by Charles H. Leonarda City Engineer, with the Re-corder of said City of Albany on the 26th day of March, 1928.

Section 2. That the probable cost of making said improvement of said Seventh Street from the east curb line of Calapooia Street to the east line of Yukon Street in said City in the manner heretofore determined by the Council of said City and in and by said Resolution No. 9, to be paid by the owners of the real property adjacent to said portion of Seventh Street is hereby declared to be the sum of \$19,614.41.
