# ORDINANCE NO. 1183

An Ordinance to establish and define the fire limits of the City of Albany, Oregon, and to repeal Ordinance 993, entitled "An Ordinance to Establish and Define the Fire Limits of the City of Albany and to Repeal Ordinance Number 893," passed by the Council on the 6th day of June, 1917, and approved by the Mayor on the 6th day of June, 1917.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The fire limits of the City of Albany, Oregon, shall be bounded by a line commencing at a point where the center line of Washington Street intersects the south bank of the Willamette River, and running thence southerly following the center line of Washington Street to the center line of the alley between Second and Third Streets; thence easterly along the center line of said alley to the center line of Ferry Street; thence southerly following the center line of Ferry Street to the center line of Third Street; thence easterly following the center line of Third Street to a point 67.8 feet westerly from the west line of Lyon Street; thence southerly parallel with the west line of Lyon Street to a point in the center of Fourth Street; thence easterly along the center line of Fourth Street to a point 67.8 feet easterly from the east line of Lyon Street; thence northly parallel with the east line of Lyon Street to a point 50 feet south of the south line of Second Street; thence easterly parallel with the south line of Second Street to the center line of Baker Street; thence northerly following the center line of Baker Street to a point equally distant from the north line of First Street to the south line of Water Street; thence westerly parallel with the north line of First Street to the center of Lyon Street; thence northerly following the center line of Lyon Street to the south bank of the Willamette River; thence westerly along the south bank of the Willamette River and following the meanderings thereof to the place of beginning; provided, however, that the Council of the City of Albany, Oregon, may at its discretion, and whenever the exigencies of the situation demand, issue special building permits in such cases as to it may seem proper, within the above limits, lying and being north of Water Street.
