AN ORDINANCE to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oregon, has determined to make in Resolution No. 23, adopted by said Council on the 24th day of June, 1925, on Sherman Street, from the south line of Water Street to the north line of First Street in said City; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said Sherman Street that is assessed upon each lot, or part thereof, adjacent to said portion of Sherman Street to be so improved; to authorize and direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens as provided by the Charter of said City City;

WHERMAS, on the 24th day of June, 1925, the Council of the City of Albany, Oregon, duly adopted a resolution requiring Charles H. Leonard, an Engineer, to prepare and file in the office of the Recorder of said City on the 24th day of June, 1925, plans, specifications and estimates of the propable cost of making the improvement of Sherman Street in said City, from the south line of Water Street to the north line of First Street, with a suitable hard surface pavement to be selected and approved by the Council; and

WHEREAS, the said Engineer pursuant to said resolution made plans, specifications and estimates as directed thereby for the improvement of said Sherman Street, and filed the same in the office of the Recorder of said City on the 24th day of June, 1925.

WHRREAS, the Council of said City on the 24th day of June, 1925, by Resolution No. 25 duly adopted by said Council, determined and resolved that it deemed it expedient and that the Council proposed to improve Sherman Street from the south line of Water Street to the north line of First Street in the City of Albany, Orgon in the manner provided in said Resolution No. 23, and

WHEREAS, in and by said Resolution No. 23, adopted as aforesaid by the Council, the Recorder of said City was duly ordered and directed to give notice of said proposed improvement of said Sherman Street from the south line of Water Street to the north line of First Street, as provided by the charter and ordinances of said City, and

WHEREAS, the Recorder, in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said proposed improvement of said Sherman Street in the manner provided by said Resolution and the charter and ordinances of said City, and

WHEREAS, the said Council in and by said "esolution No. 23 ascertained and determined the total probable cost of making said improvement of said Sherman Street to be paid by the owners of the real property adjacent to said portion of said Sherman Street to be improved as spelified in said nesolution No. 23, to be the sum of \$2489.62, and

WHEREAS, by Ordinance No. 1198 after due notice for the time and in the manner provided by law, the bid of U.G. Hayne for the making of said improvement of said portion of Sherman Street, was accepted, and the Mayor and Recorder of the City of Albany, were thereby authorized to enter into a contract with U.G. Hayne for the making of said improvement in accordance with said bid with concrete pavement, and in other respects in accordance with said Resolution No. 23.

THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Sherman Street in the City of Albany, Oregon, from the south line of Water Street to the north line of First Street shall be improved as followe:

let:

By grading said street to the proper sub-grade; By paving the roadway of said Street, full width, with full intersections (except as noted in the plans and specifications) with Warren-ite Bitulithic payement or with Portland cement concrete payement;

By laying and constructing pavement headers; 3rd:

By constructing concrete curbs wherever necessary. By constructing catch basins and inlets; By laying vitrified sewer pipes; 4th:

5th:

6th:

by tapping the main sewer.

Said improvement to be made all in accordance with said desolution No. 23, and the plane and specifications for said improvement filed by Charles H. Leonard, City Engineer, with the Reporder of said City of Albany on the 24th day of June, 1925.

Section 2. That the probable cost of making said improvement of said Sherman Street from the south line of Water Street to the north line of First Street in eaid City in the manner heretofore determinedby the Council of said City, and in and by said resolution No. 23, to be paid by the owners of the real property adjacent to said portion of Sherman Street is hereby declared to be the sum of \$2489.62.

That the proportionate share of said probable cost of said improvement of said Sherman Street assessed upon each lot, or part thereof, adjacent to said portion of Sherman Street to be improved, as aforesaid, and as determined by said Council and in and by said Resolution No. 23, is hereby ascertained and declared to be the sum set and placed immediately after the separate description of each of such lots, or parts thereof, as follows:

Section 4 .--That the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the assessments hereby made and declared by this ordinance, together with the names of the respective emers of each lot, or part thereof, hereinab@wedescribed, in the Docket of City Liens of the City of Albany, as provided by the charter of the said City.
