

**ORDINANCE NO. 1201**

**A N ORDINANCE** to ascertain and determine the probable cost of constructing a lateral sewer, which the Council of the City of Albany, Oregon, has determined by Resolution No. 13, adopted on the 13th day of May, 1925, beginning at the manhole in Oak Street trunk sewer, between Sixth and Seventh Streets, and running thence westerly through Block Two (2) and into Block One (1) in Hackleman's Heirs First Addition to the City of Albany, Oregon, a distance of 578 lineal feet, to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement that is assessed upon said lot or part thereof, or parcel or tract of land, adjacent to said improvement, to direct the Recorder of said City to enter a statement of such assessment in the docket of City Liens, as provided by the charter of said City.

**WHEREAS**, on the 13th day of May, 1925, the Council of the City of Albany, Oregon, duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the construction of sewer beginning at the manhole in the Oak Street trunk sewer, between Sixth and Seventh Streets, running thence westerly through Block Two (2) and into Block One (1) in Hackleman's Heirs First Addition to the City of Albany, Oregon, a distance of 578 lineal feet, and for estimates of the probable cost of the work to be done, and requiring such plans and specifications and estimate of the probable cost to be filed in the office of the Recorder of the City of Albany, Oregon, on the 13th day of May, 1925, and

**WHEREAS**, the City Engineer of said City, pursuant to said Resolution No. 13 made said plans, specifications and estimates, as directed by said Resolution, for the construction of said lateral sewer, and filed the same on the 13th day of May, 1925, and

**WHEREAS**, the Council on the 13th day of May, 1925, by Resolution No. 13, duly adopted by the said Council, determined and resolved that it deemed it expedient, and said Council proposed to construct said lateral sewer, beginning at the manhole in the Oak Street trunk sewer, between Sixth and Seventh Streets, and running thence westerly through Block Two (2) and into Block One (1) in Hackleman's Heirs First Addition to the City of Albany, Oregon, a distance of 578 lineal feet, and

**WHEREAS**, the Recorder in pursuance of said Resolution No 13 gave due notice of said proposed improvement in the manner provided by the charter of said City, and on the 12th day of August, 1925, pursuant to said notice W.S.Weaver submitted his bid to the Council for the making of said improvement for the sum of \$743.44, which said bid was received and accepted by said Council in and by Ordinance No. 1199, passed by the Council the 12th day of August, 1925, and approved by the Mayor the 12th day of August, 1925.

**THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:**

**Section 1.** That an eight inch vitrified terra cotta sewer shall be constructed beginning at the manhole in the Oak Street trunk sewer between Sixth and Seventh Streets and running thence westerly through Block Two (2) and into Block One (1) in Hackleman's Heirs First Addition to the City of Albany, Oregon, a distance of 578 lineal feet, in accordance with Resolution No. 13, and the plans and specifications filed by Charles H. Leonard, City Engineer of said City, in the office of the Recorder of the said City of Albany, Oregon, May 13, 1925.

**Section 2.** That the probable cost of making such improvement in the manner hereinbefore determined by the Council of said City of Albany, Oregon, in and by said Resolution No. 13, and by the bid of said W.S.Weaver, is hereby declared to be the sum of \$976.02, and the probable cost of said improvement, to be paid by the owners of property adjacent to and particularly benefited thereby, is the sum of \$713.51.

**Section 3.** That the proportionate share of such probable cost of said improvement assessed on each lot or part thereof, or parcel or tract of land adjacent to said improvement as aforesaid, and as determined by said Council, is hereby ascertained and determined to be the sum set and placed immediately after the separate description of said lots or parts thereof, or parcels or tracts of land, as follows, to-wit:
