

ORDINANCE NO. 1205

AN ORDINANCE declaring a surplus on account of the improvement by Guy F. Pyle, of Calapooia Street, from the south line of Ninth Street to the north curb line of Thirteenth Street, in the City of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens, in the City of Albany, Oregon, for making such improvement, their proportionate share of such ~~improvement~~ surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:-

Section 1. That a surplus of \$1286.66 is hereby ascertained and declared to exist upon the completion of the contract entered into by the City of Albany, Oregon, and Guy F. Pyle for the improvement of Calapooia Street from the south line of Ninth Street to the north line Thirteenth Street in said City, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany, Oregon, is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, the sum of \$1286.66, based on the several amounts heretofore assessed and entered therein to defray the cost of improving said Street, said surplus being in favor of the following named persons, owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:


