

ORDINANCE No. 1206

AN ORDINANCE declaring a surplus on account of the improvement by C.E. Davis of Second Street from the west line of Cleveland Street to the west line of Geary Street, in the City of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$11.79 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and C.E. Davis for the improvement of Second Street from the west line of Cleveland Street to the west line of Geary Street, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, a credit of \$11.79, based upon the several amounts heretofore assessed and entered therein to defray the cost of improving of said Street, said surplus being in favor of the following named persons, owners or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:-
