ORDINANCE NO. 1818

AN ORDINANCE to ascertain and declare the deficit existing on account of the improvement by U.G. Hayne of Denver Street from the north curb line of Eighth Street to the south curb line of Santiam Road, in the City of Alomny, and to reassess, ascertain, And determine and declare the proportionate share of such deficit, upon each lot, or part thereof, adjacent to said portion of said Street, and to authorize and direct the Recorder of said City to enter a state-ment of such deficit and reassessment in excess of the original assessment heretofore made, apportioning such excess equitably to the various lots, or parts thereof, especially and particularly benefited by such improvement, in the nocket of Gity Liens, as provided by the charter of said City.

THE PEOPLE OF THE CITY OF ALBAMY DO ORDAIN AS FOLLOWS:

Section 1. That a deficit of \$23.86 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and U.G. Hayne, for the improvement of Denver Street from the north curb line of Eighth Street to the south ourb line of Santiam Road in said

Section 2. That the proportionate snare of said deficit hereby aggertained and declared to exist upon the completion of said improvement of said Denver fitreet is hereby assessed upon each lot, or part thereof, adjacent to said portion of said Denver Street improved as aforesaid, in the sum set and placed immediately after the separate description of each of such lots, or parts thereof, as follows, to-wit:
